







#### **Collector Current vs. Collector-Emitter Voltage:**




#### **Collector Current vs. Collector-Emitter Voltage, saturated**





## Relative CTR vs. Forward Current ( at $V_{CF}=5 V$ )



## **Switching time vs. Load Resistance:**





#### Soldering:




