E-plane cut scanning direction:



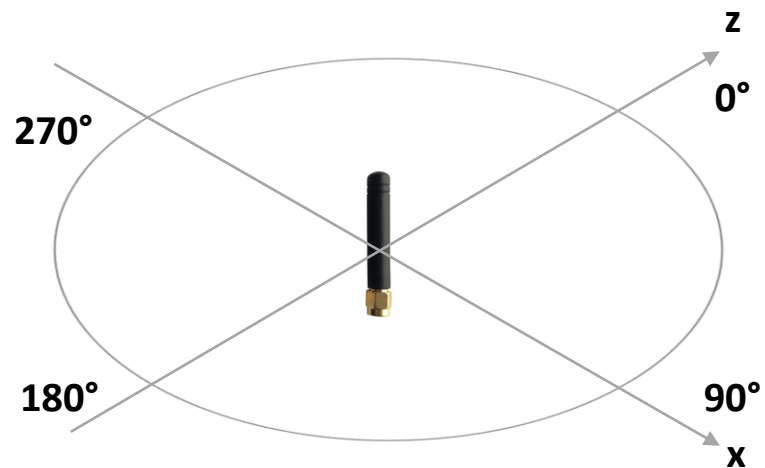

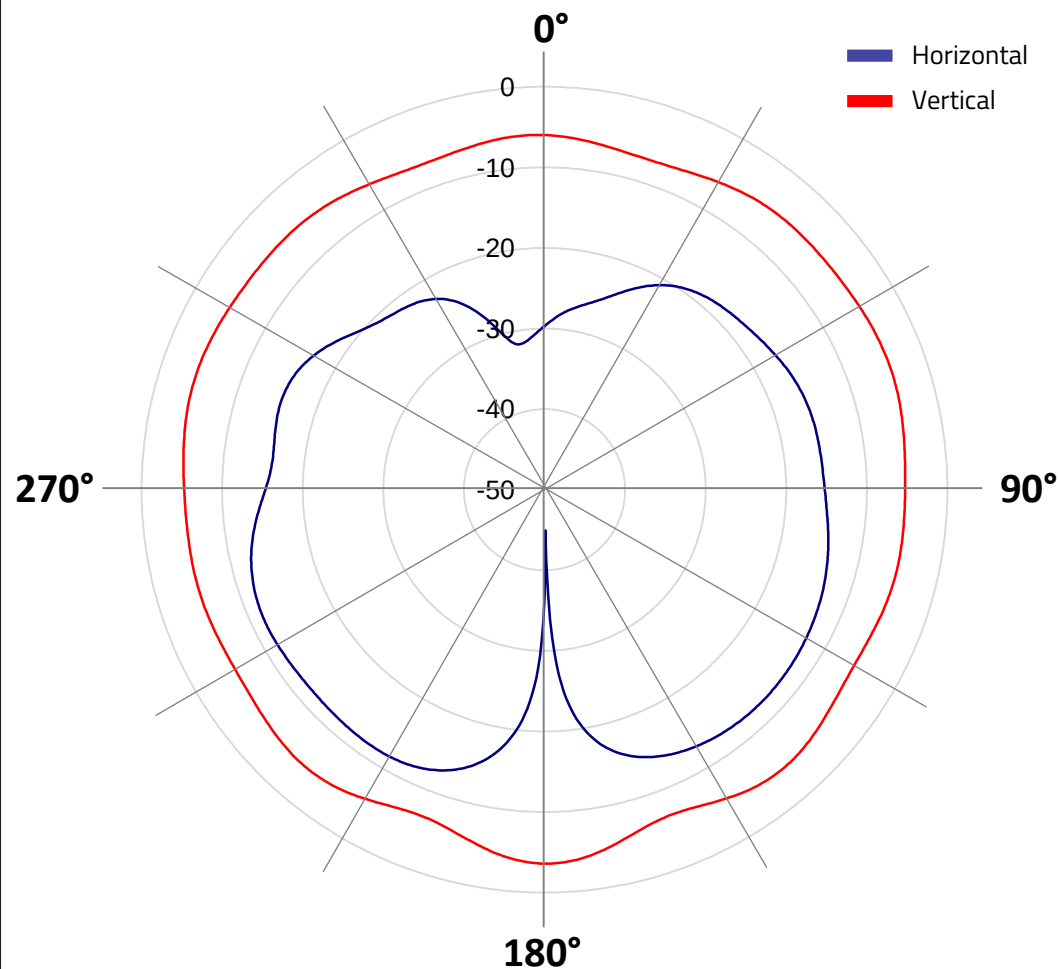

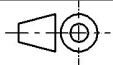

Soldering:

- Do not solder.

Cleaning and Washing:

- Washing agents used during the production to clean the customer application might damage or change the characteristics of the component. Washing agents may have a negative effect on the long-term functionality of the product.
- Using a brush during the cleaning process may break the module. Therefore, we do not recommend using a brush during the PCB cleaning process.

Potting and Coating:

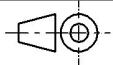

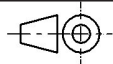
