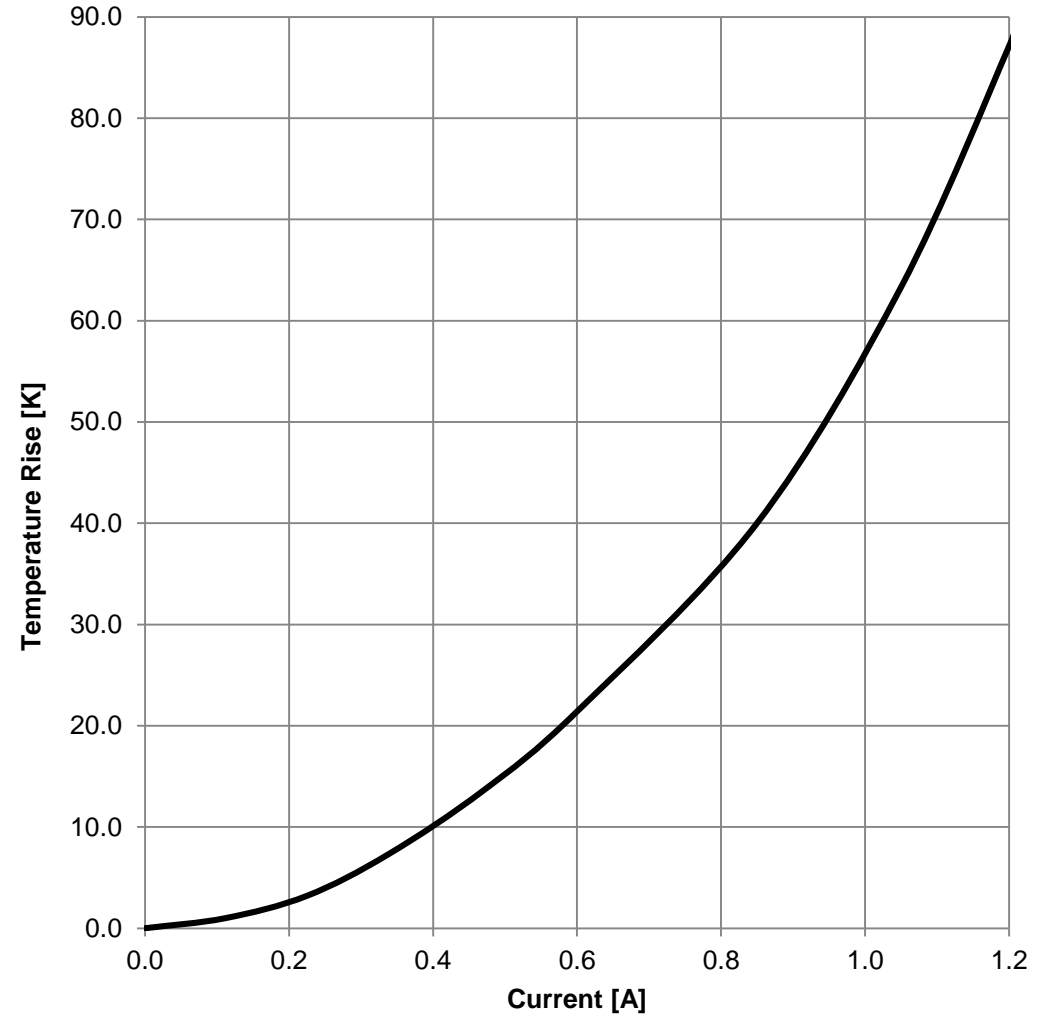

Typical Temperature Rise vs. Current Characteristics:

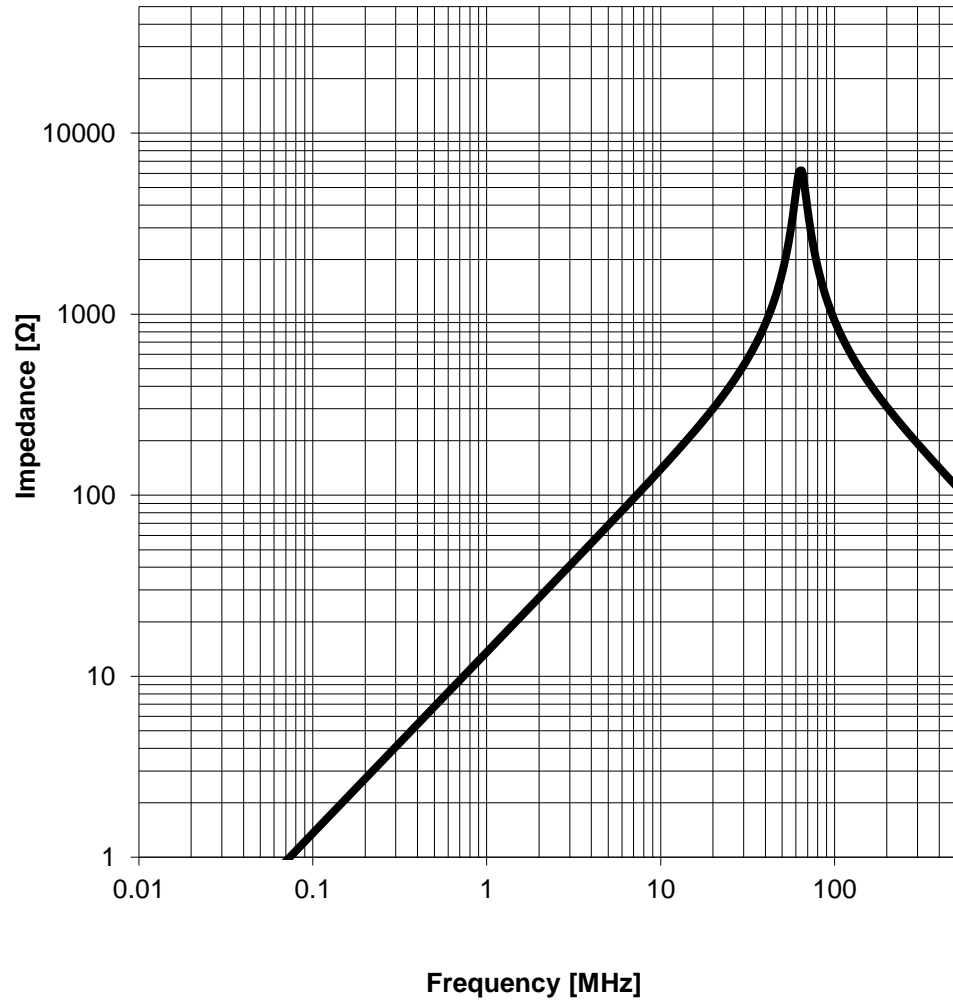







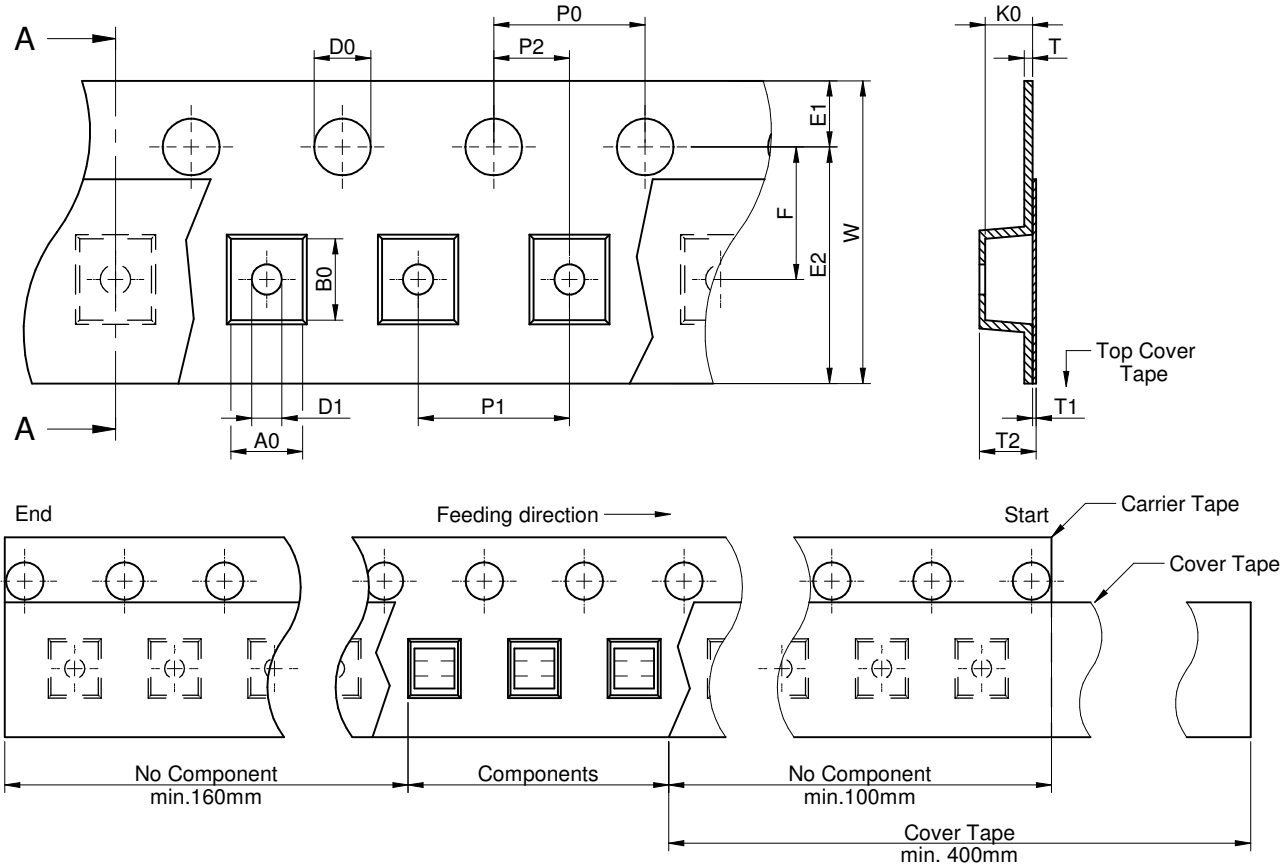

Cleaning and Washing:

Potting:



Storage Conditions:


