## Derating Curve:

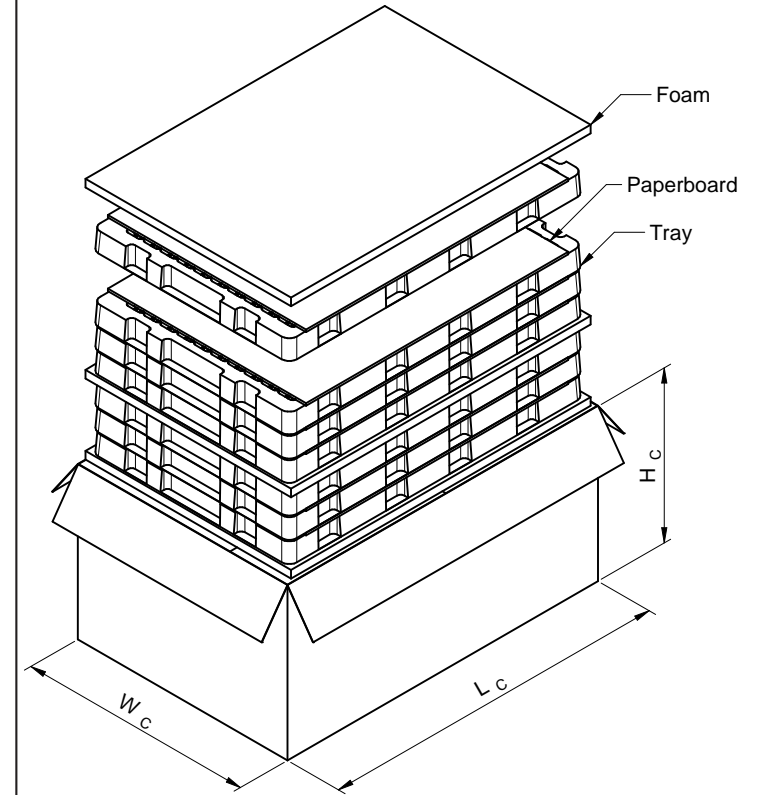

#### Soldering:



#### Packaging:


