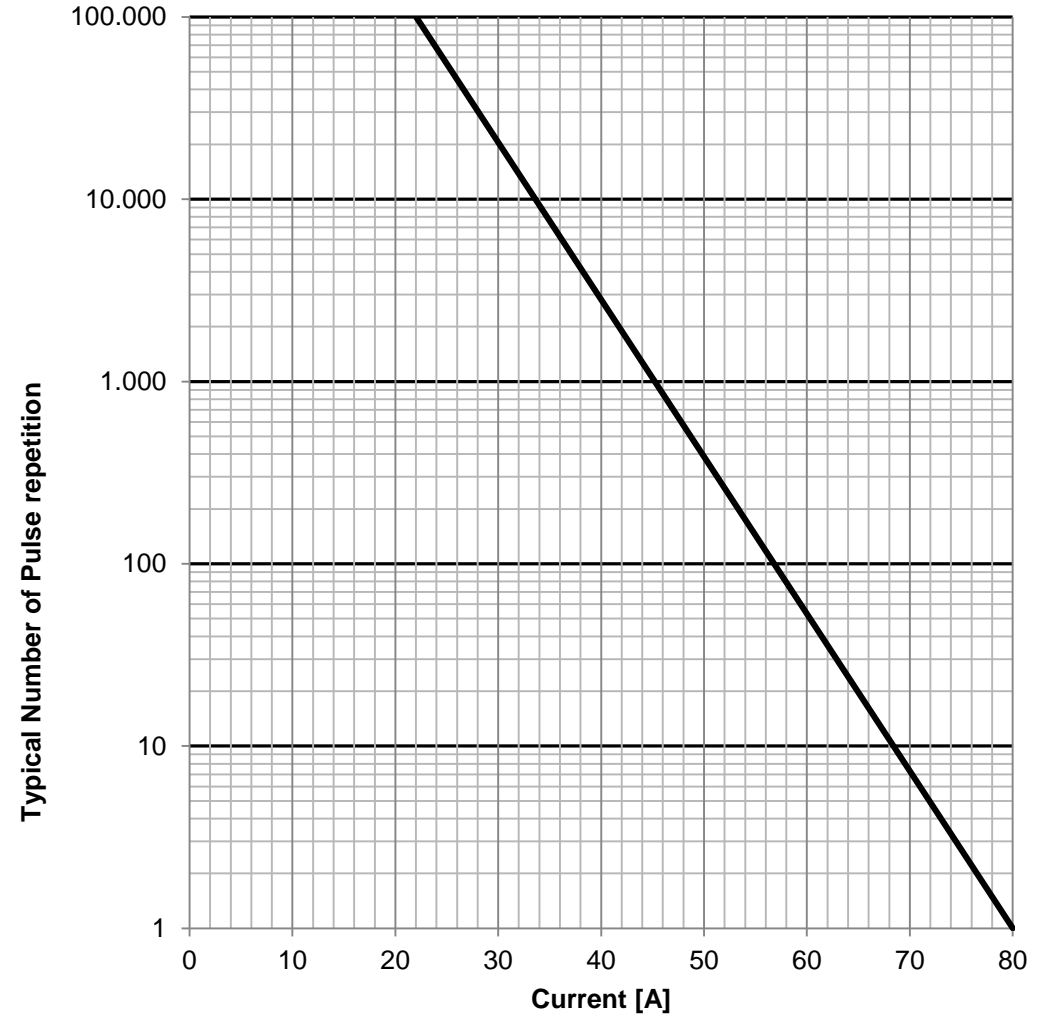

### Typical Number of Pulse Repetition:



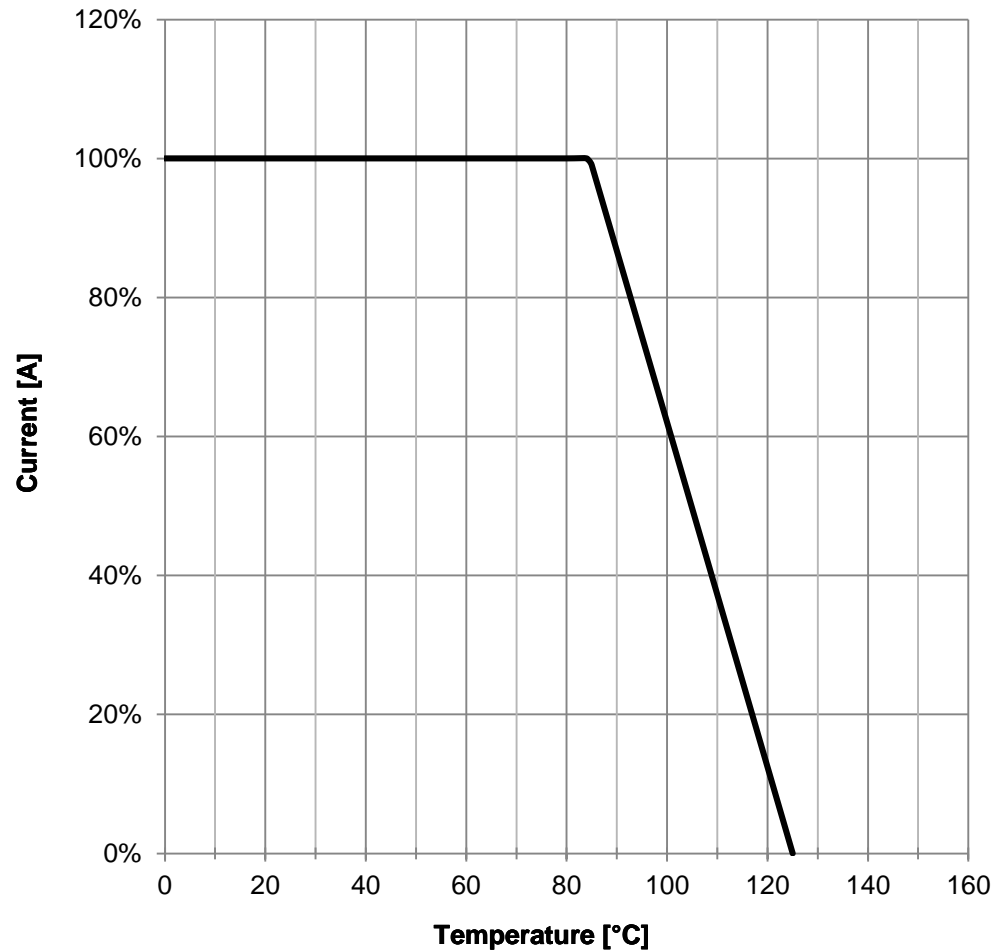

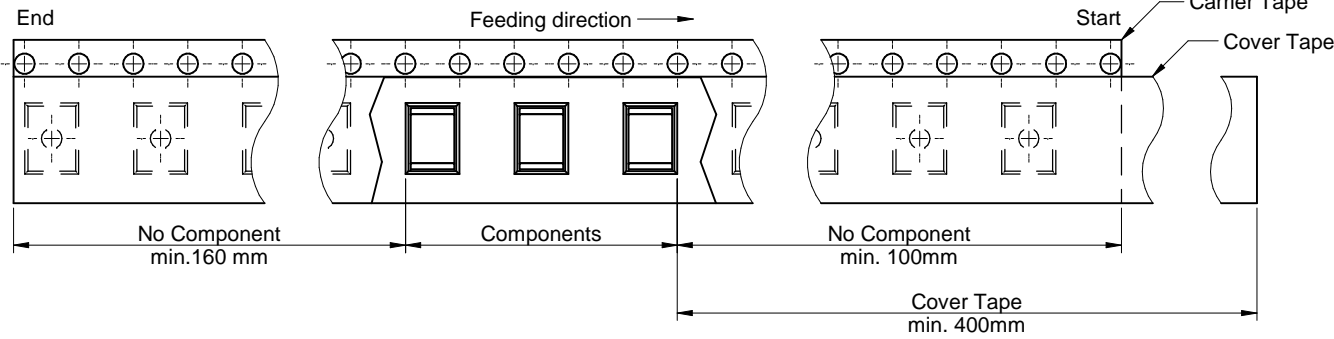
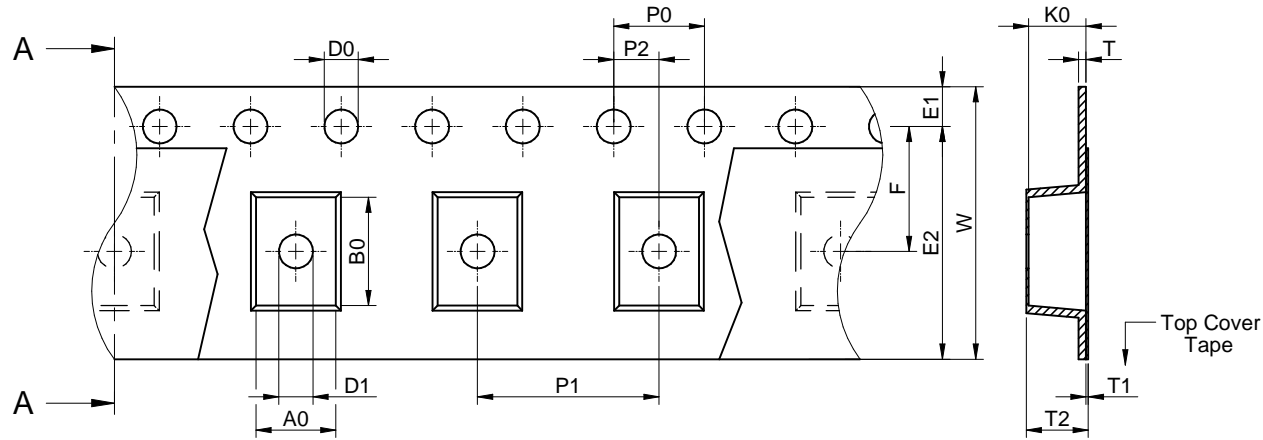
## Derating Curve:
