




Capacitance Change vs. Temperature:







This degradation can increase the series resistance of the electrode and decrease the capacitance value. For DC operation, the parameter drift is significantly less pronounced. Plastic enclosures and resins do not provide complete protection against humidity. Additional protective measures, implemented by customers in their applications, can offer enhanced defense against humidity ingress.
