




Capacitance Change vs. Temperature:







Storage conditions:

- The environment in which the capacitors are operated and stored has to have atmospheric characteristics and must be free of dew condensation and toxic gases (e.g. chlorine, ammonia, sulfur, hydrogen sulphide and hydrogen sulfate).

It is crucial to precisely test plastic boxed capacitors under the most extreme anticipated conditions of temperature and humidity in their final application to ensure that any parameter drift does not cause circuit malfunction. If humidity infiltrates the film, the metal layer may deteriorate, particularly under AC operation (polarity changes), which is exacerbated by elevated temperatures. This degradation can increase the series resistance of the electrode and decrease the capacitance value. For DC operation, the parameter drift is significantly less pronounced. Plastic enclosures and resins do not provide complete protection against humidity. Additional protective measures, implemented by customers in their applications, can offer enhanced defense against humidity ingress.

Packaging:
