







#### **Collector Current vs. Collector-Emitter Voltage:**




#### **Collector Current vs. Collector-Emitter Voltage, saturated**





## Absolute CTR vs. Forward Current ( at $V_{CE}=5 V$ )




### Relative CTR vs. Forward Current ( at $V_{CF}=5 V$ )





### Relative CTR vs. Forward Current ( at V<sub>CF</sub>=0,4 V )



#### Soldering:




