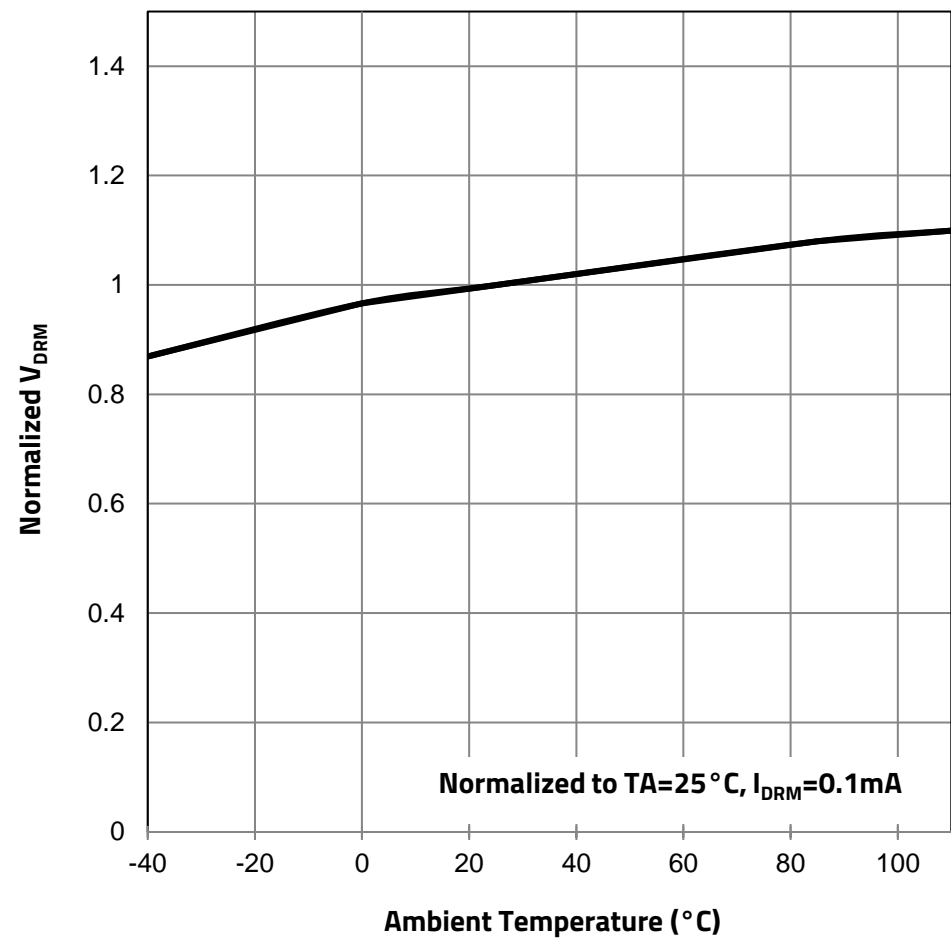
Peak Off-State Terminal Current vs. Ambient Temperature:



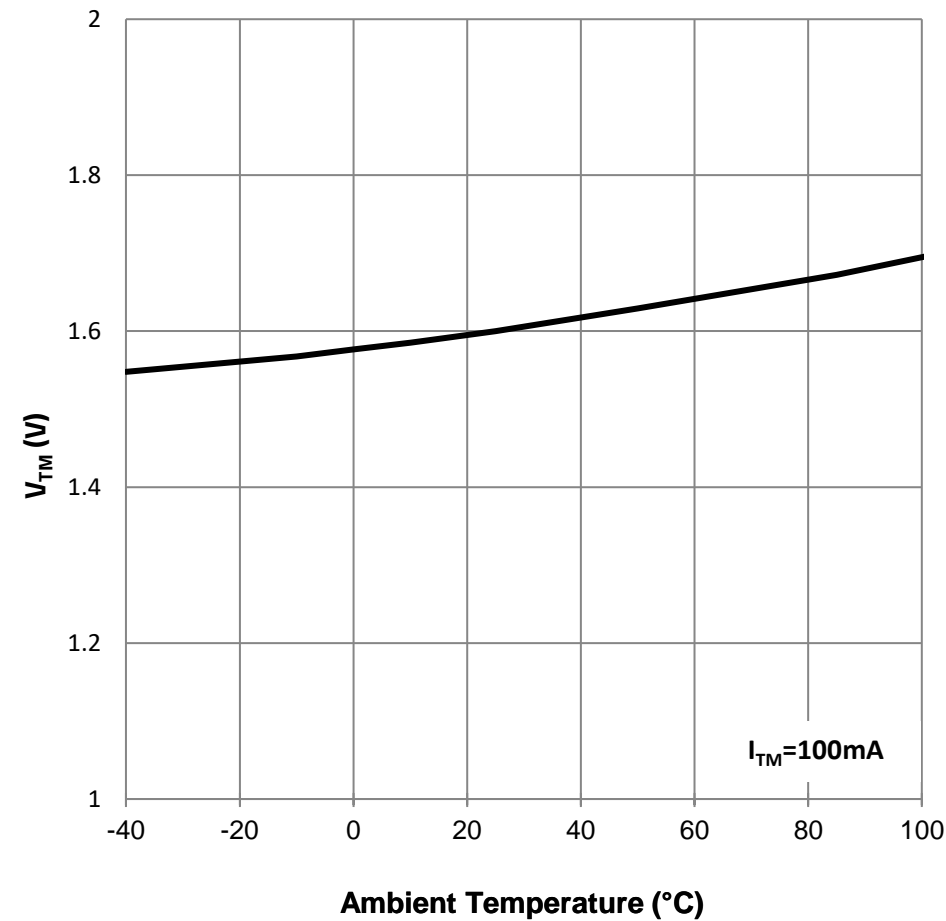



Normalized Off-State Terminal Voltage vs. Ambient Temperature:



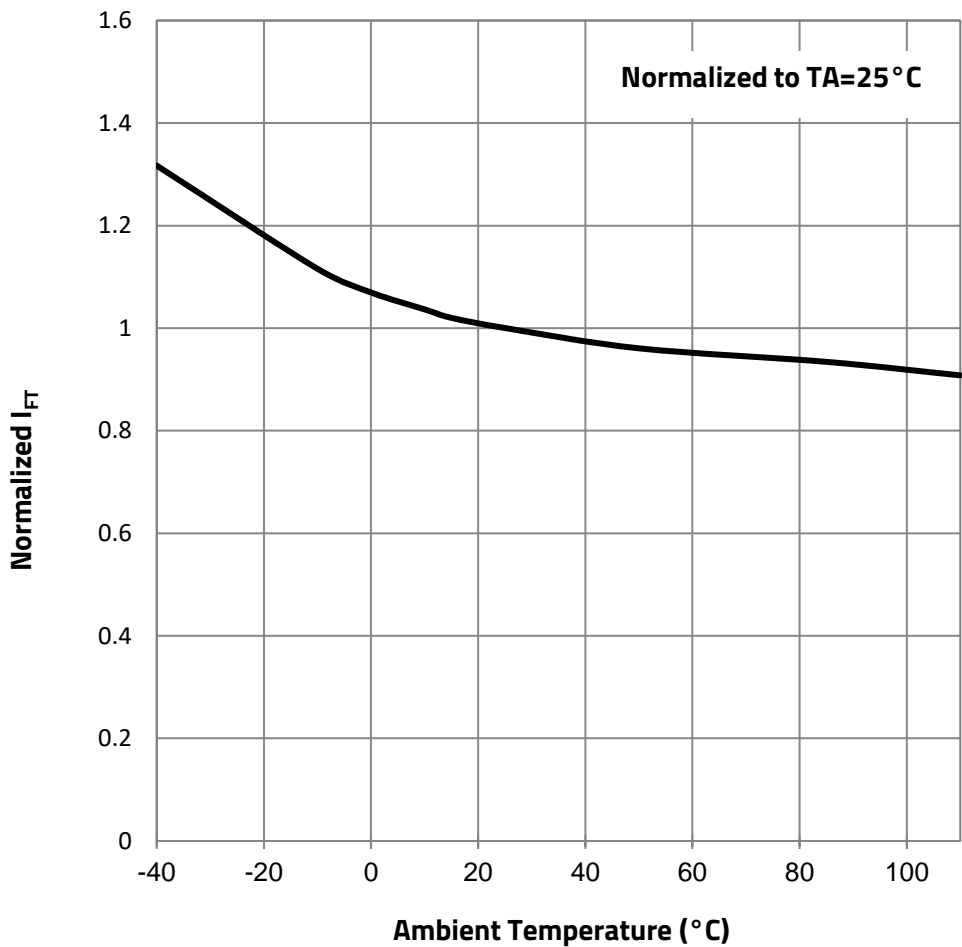

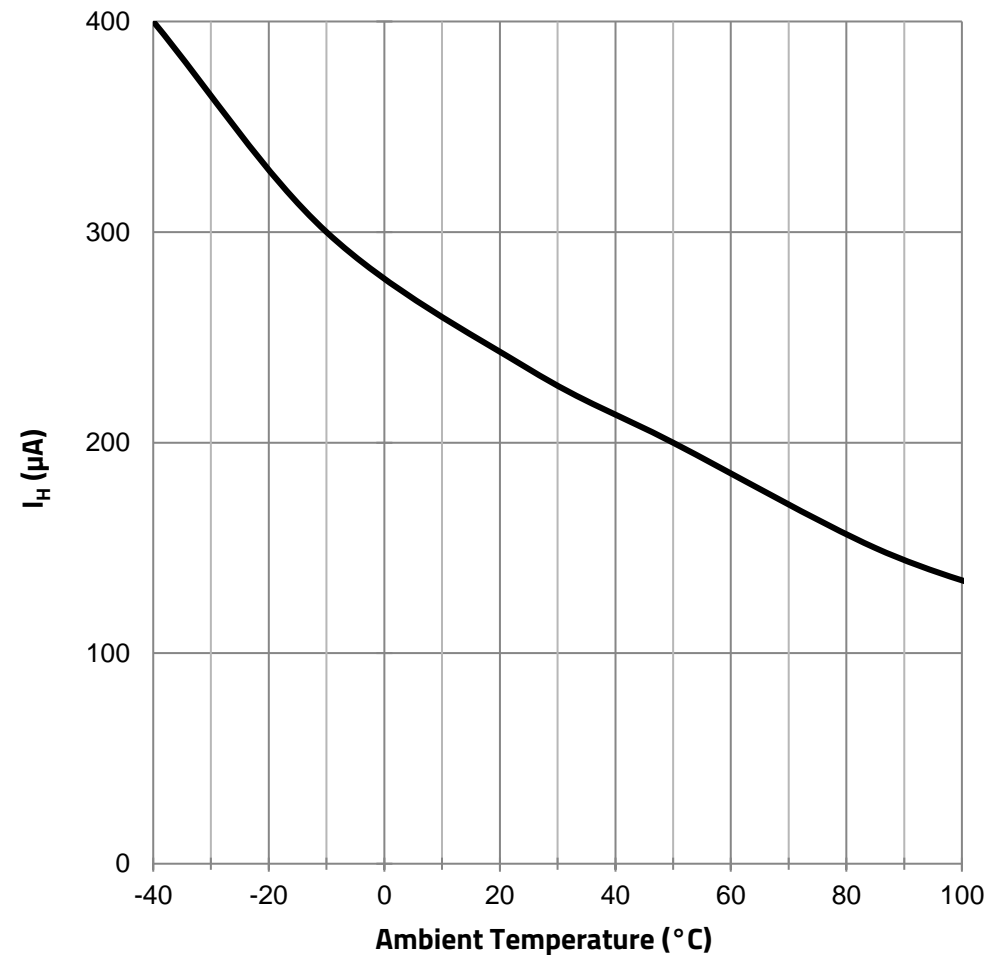



Normalized Trigger Current vs. Ambient Temperature:



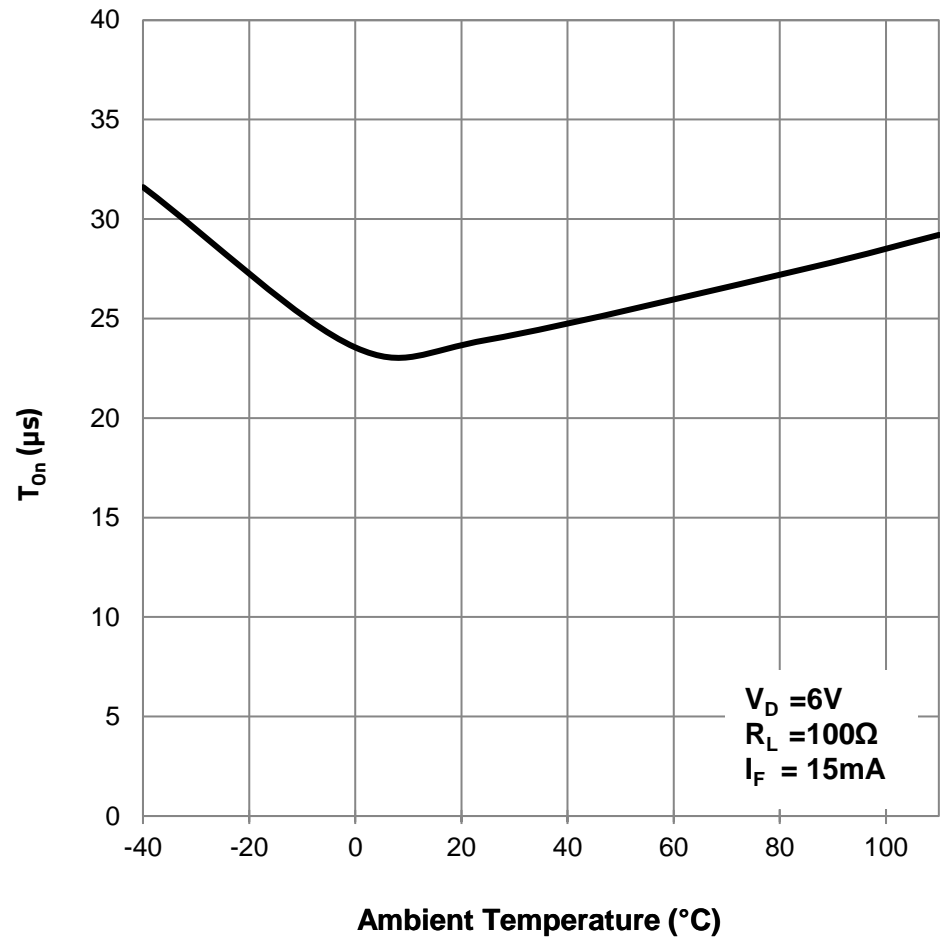

On-State Terminal Voltage vs. On-State Terminal Current:



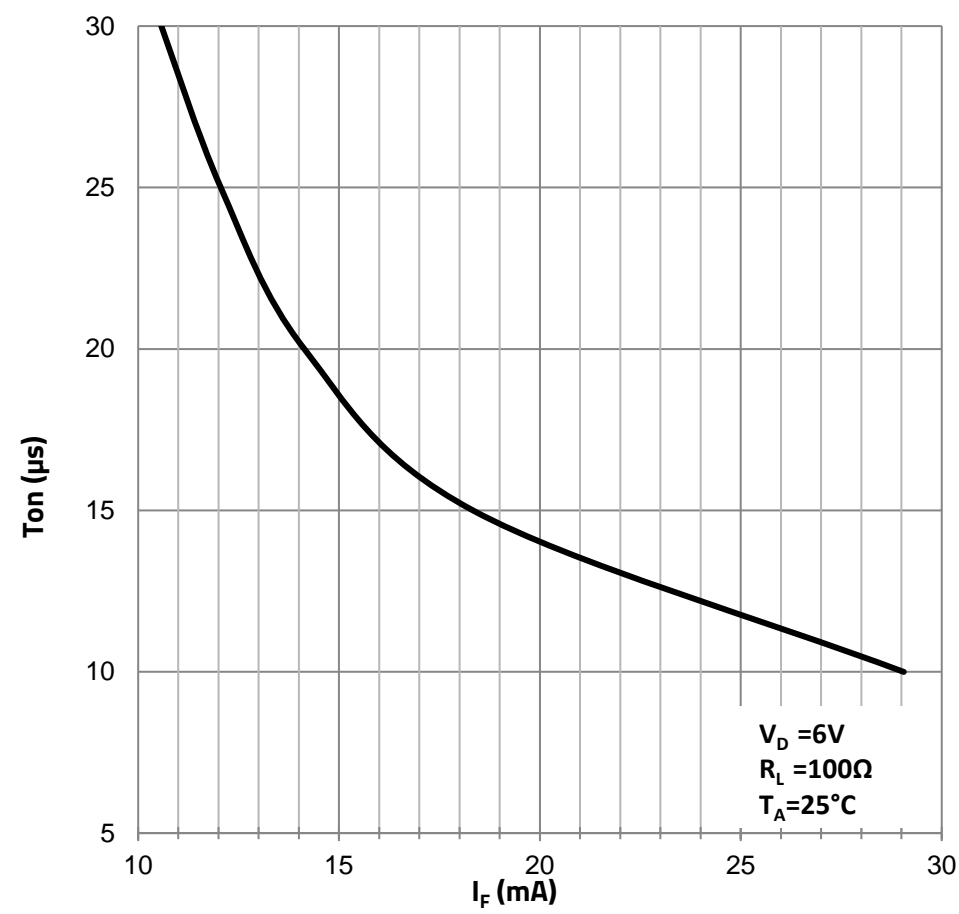

Soldering:






