Collector Current vs. Distance:

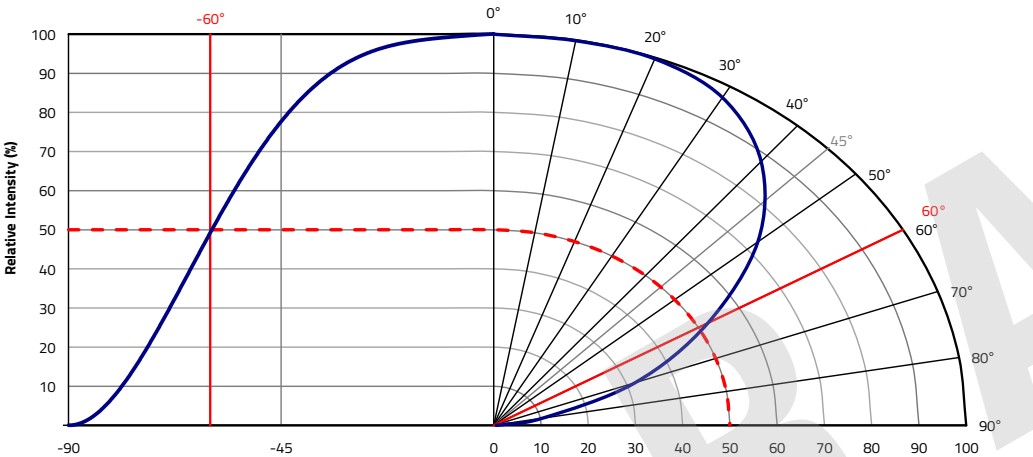

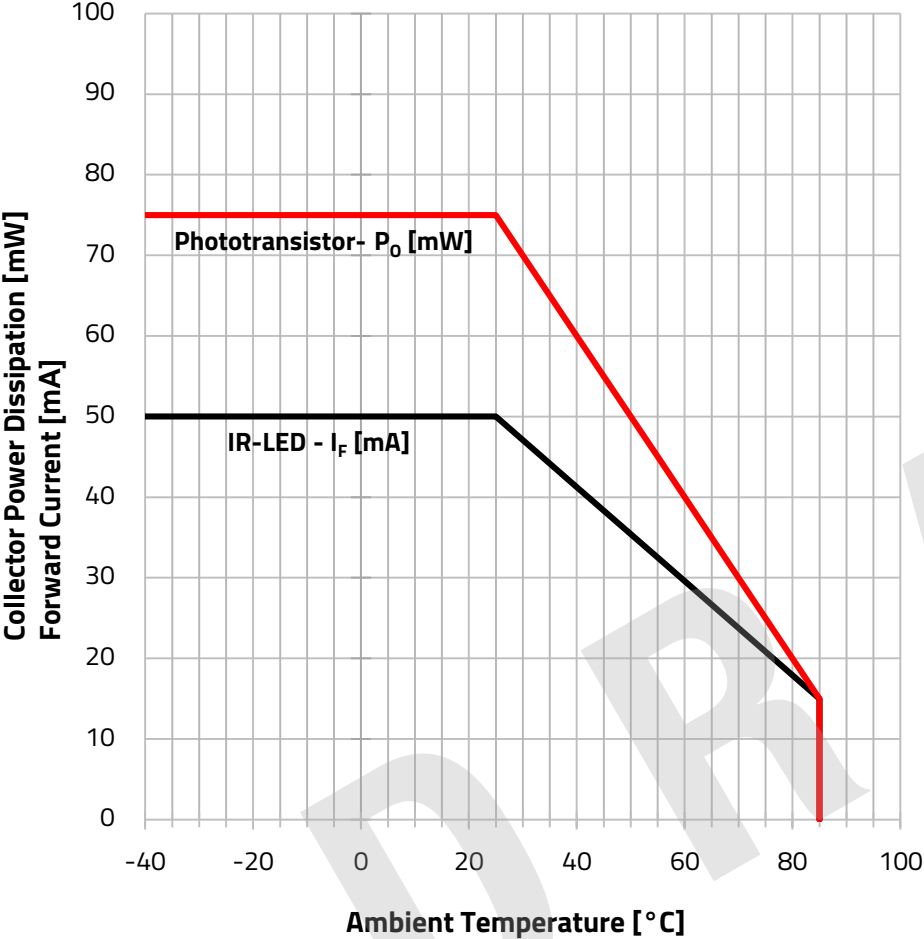
Forward Current vs. Forward Voltage – LED



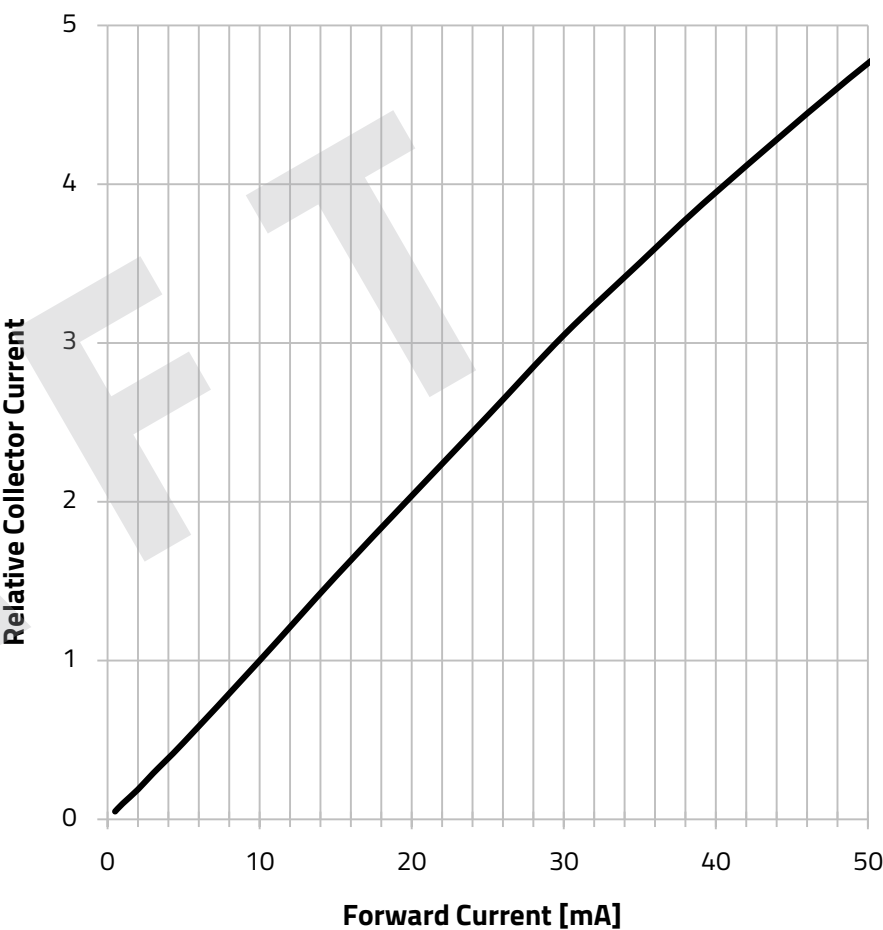



Derating Curve:



Relative Collector Current vs. Forward Current:

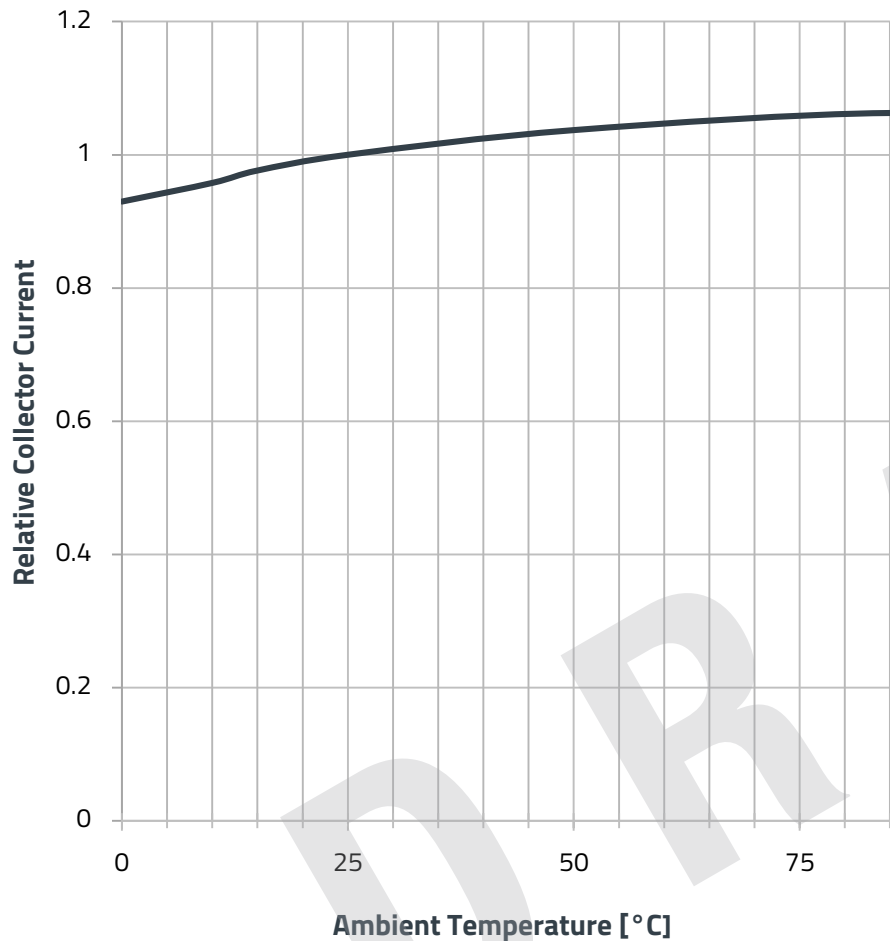

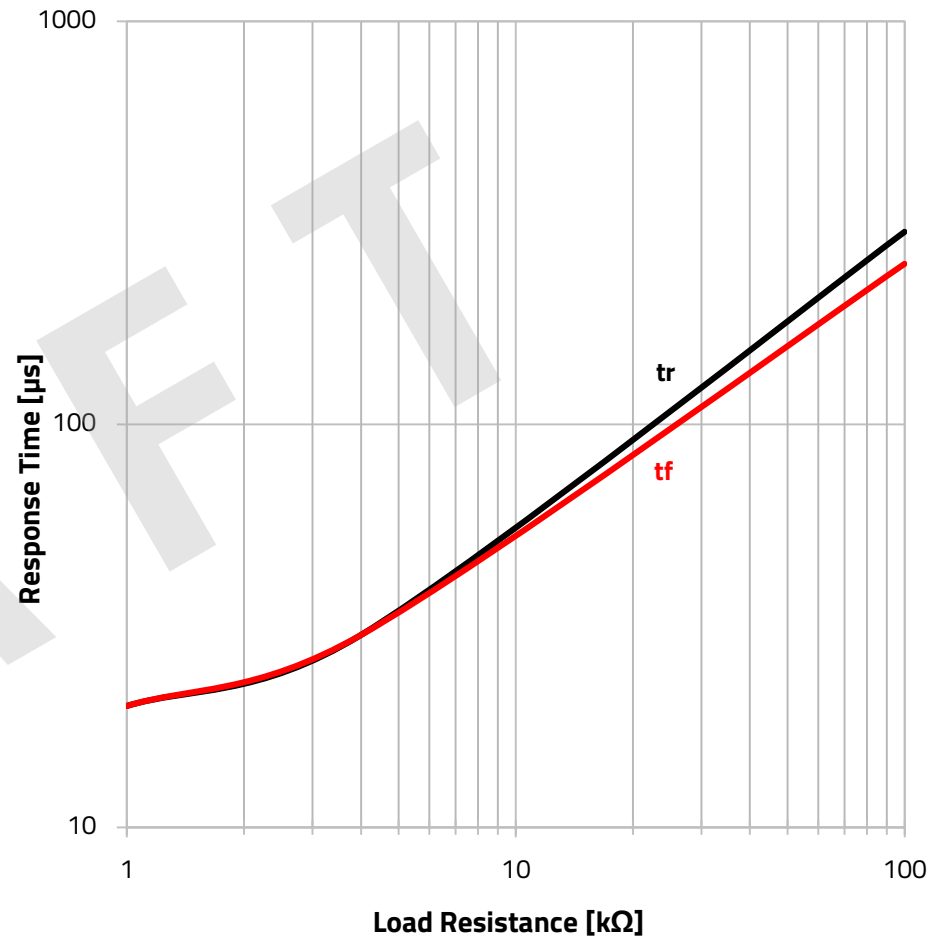

Collector Current vs. Ambient Temperature:








Switching time vs. Load Resistance:



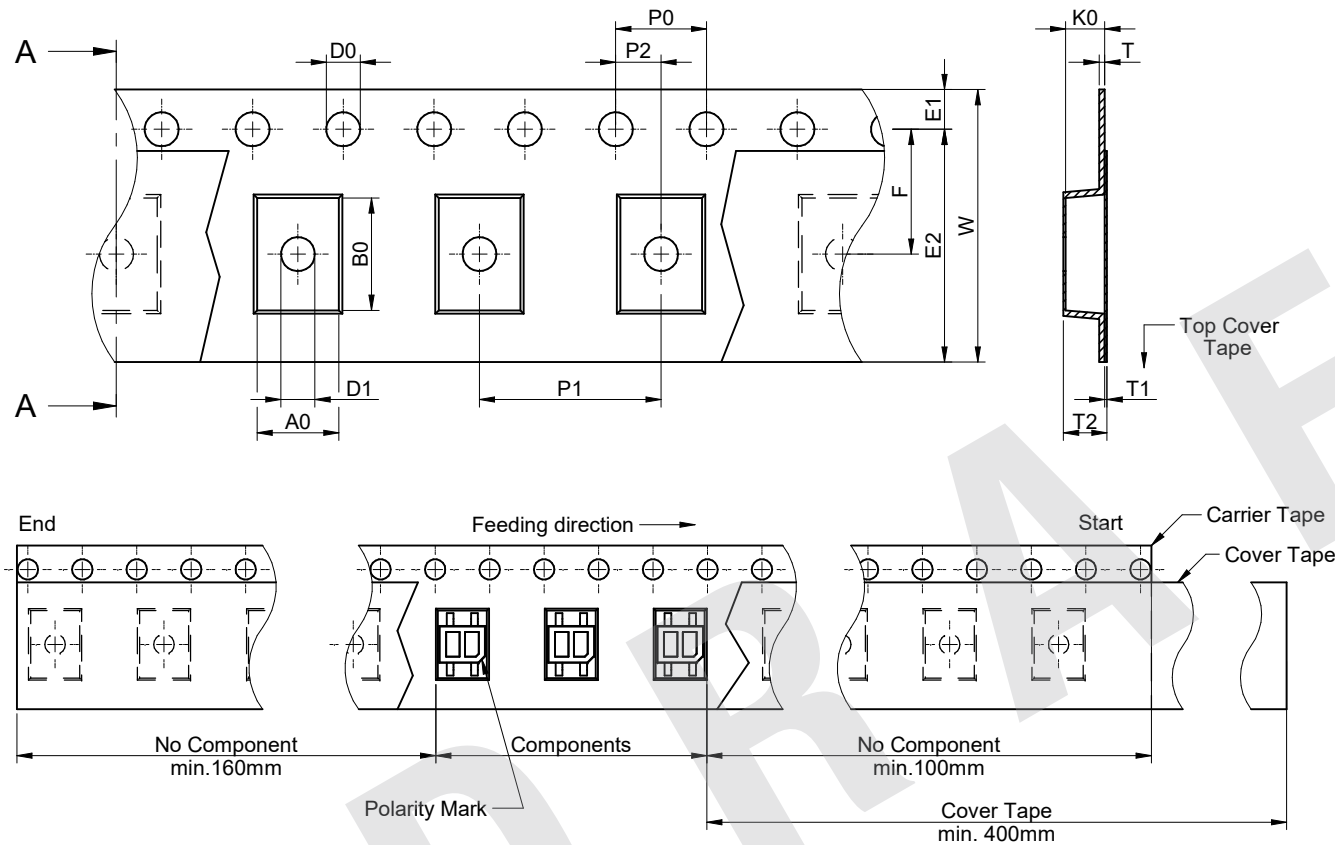
