### Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.
- All other soldering methods are at the customers' own risk.
- Strong forces which may affect the coplanarity of the components' electrical connection with the PCB (i.e. pins), can damage the part, resulting in avoid of the warranty.

### Cleaning and Washing:

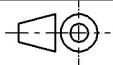
### Storage Conditions:

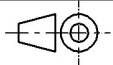

Würth Elektronik eiSos Group must be informed about the intent of such usage before the design-in stage. In addition, sufficient reliability evaluation checks for safety must be performed on every electronic component which is used in electrical circuits that require high safety and reliability functions or performance.
