

Product Specific:

Cleaning and Washing:

• Washing agents used during the production to clean the customer application might damage or change the characteristics of the component, marking or plating. Washing agents may have a negative effect on the long-term functionality of the product.

Storage Conditions:

- A storage of Würth Elektronik products for longer than 12 months is not recommended. Therefore, all products shall be used within the
 period of 12 months based on the day of shipment.
- Do not expose the components to direct sunlight.
- The storage conditions in the original packaging are defined according to DIN EN 61760-2.
- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.

Packaging:

• The packaging specifications apply only to purchase orders comprising whole packaging units. If the ordered quantity exceeds or is lower than the specified packaging unit, packaging in accordance with the packaging specifications cannot be ensured.

Handling:

- · It is recommended to compress the material with equal pressure on the whole surface.
- · It is not recommendable to over-compress the EMC Gasket.
- The temperature rise of the component must be taken into consideration. The operating temperature is comprised of ambient temperature and temperature rise of the component. The operating temperature of the component shall not exceed the maximum temperature specified.
- Do not reuse this product after removal from the mounting board.
- Due to the different expansion of the used material in the "EMC Gaskets" wrinkles can occur between the release tape and the adhesive tape. These parts can still be used.
- The adhesive tape used on EMC Gaskets provides help for the assembly process, it is not recommended to use it as a long-term fixation solution.
