




#### **Product specific:**

#### Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.
- To avoid contact finger misplacement and to avoid the soldering joints coming off, use maximum adjusted force at the Pick- and Place machine that does not exceed the recommended compression rate (of the contact fingers).
- The soldering joints must be kept clean, dry and grease free. The contact fingers should be placed onto the solder pad of the printed circuit board in a way that no tin solder is able to come into the undermost or the first elastic bending of the contact fingers. This will avoid the bending being affected.
- All other soldering methods are at the customers' own risk.

#### **Cleaning and Washing:**

• Washing agents used during the production to clean the customer application might damage or change the characteristics of the component, marking or plating. Washing agents may have a negative effect on the long-term functionality of the product.

#### Potting:

If the product is potted in the customer application, the potting material may shrink or expand during and after hardening. Shrinking
could lead to an incomplete seal, allowing contaminants into the core. Expansion could damage the components. We recommend a
manual inspection after potting to avoid these effects.

#### **Storage Conditions:**

- A storage of Würth Elektronik products for longer than 12 months is not recommended. Within other effects, the terminals may suffer degradation, resulting in bad solderability. Therefore, all products shall be used within the period of 12 months based on the day of shipment.
- · Do not expose the components to direct sunlight.
- The storage conditions in the original packaging are defined according to DIN EN 61760-2.
- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.

#### Packaging:

- The contact fingers shall not exceed the recommended compression rate. If recommended compression rate is exceeded there is a risk

- The temperature rise of the component must be taken into consideration. The operating temperature is comprised of ambient temperature and temperature rise of the component. The operating temperature of the component shall not exceed the maximum temperature specified.
