



Product specific:

Cleaning and Washing:

 Washing agents used during the production to clean the customer application might damage or change the characteristics of the component, marking or plating. Washing agents may have a negative effect on the long-term functionality of the product..

Potting:

If the product is potted in the customer application, the potting material might shrink or expand during and after hardening. Shrinking
could lead to an incomplete seal, allowing contaminants into the component. Expansion could damage the component. We recommend

- Do not expose the components to direct sunlight.

- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.


Packaging:

The packaging specifications apply only to purchase orders comprising whole packaging units. If the ordered quantity exceeds or is
