Soldering:

- Design the right angle part with consideration of the wave soldering process so that the parts will not touch the soldering wave during the soldering process or protect the switch part with cover fixture. Melt of the switch might cause malfunction.

Cleaning and Washing:

- If a series is washable, the general information section in the datasheet will contain the washability guidelines.
- Should there be no information regarding washability, the product has not been constructed to withstand a washing process.

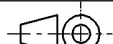
Storage Conditions:

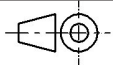

- In order to reduce the shifting of the actuator, side force shall be avoided.

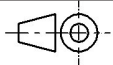
