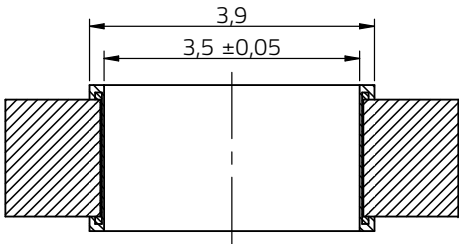
Recommended PCB Layout [mm]:

Drillhole specification for PCB:

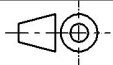
Drill hole specification for PCB:

- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.

Packaging:

Handling:

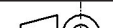
