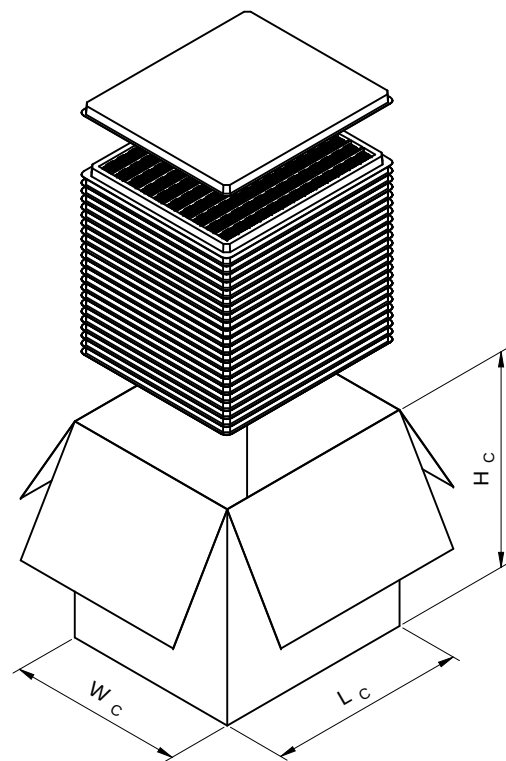

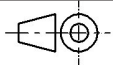
Packaging:

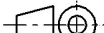
