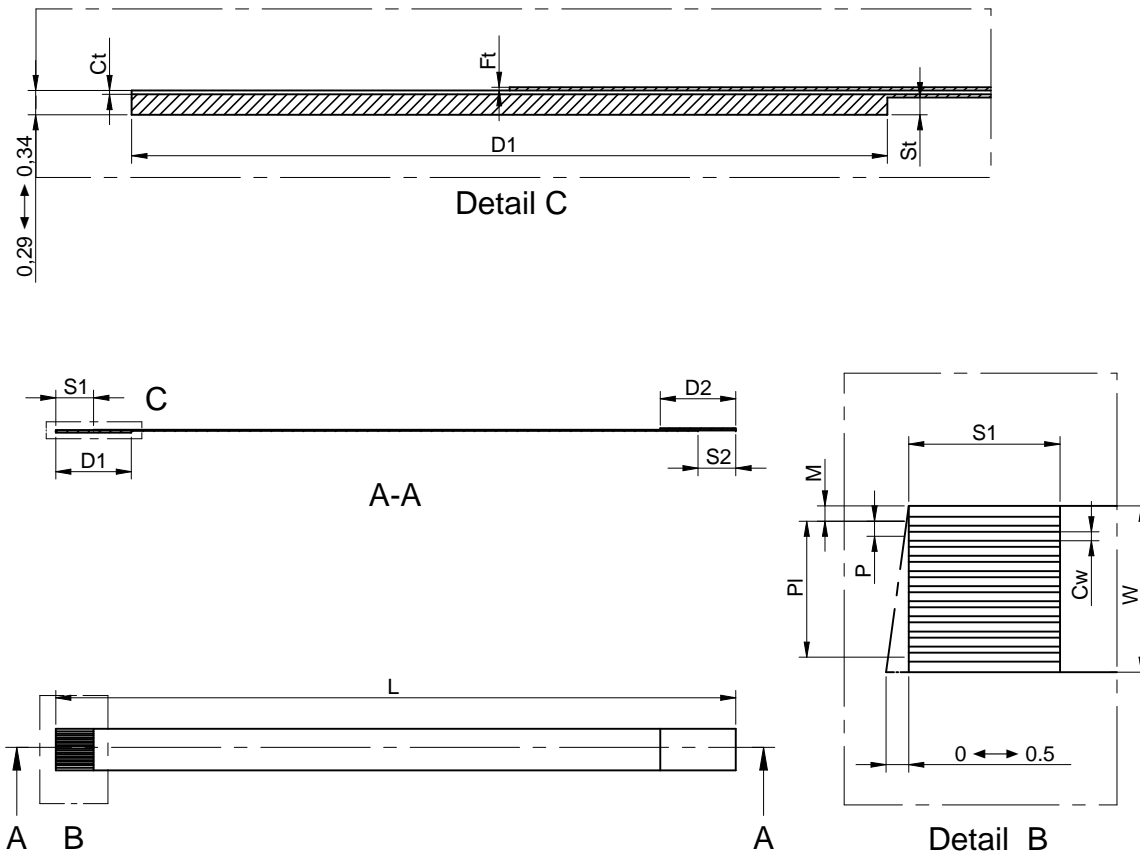





General:

- This mechanical component is designed and manufactured for use in general electronic equipment.

Würth Elektronik does not warrant any customer qualified product characteristics beyond Würth Elektronik's specifications, for its validity and sustainability over time.
- The responsibility for the applicability of the customer specific products and use in a particular customer design is always within the authority of the customer. All technical specifications for standard products do also apply to customer specific products.
- The mechanical component is designed to be used along with Würth Elektronik counterparts and tools. Würth Elektronik cannot ensure the reliability of these components while being used with other products.
- Please note that the specified current rating represents the maximum value the product can safely withstand under controlled laboratory conditions, within a defined range of ambient temperatures (@ 25°C). If the product is used in environments where the ambient temperature differs from those laboratory conditions, it is important to assess and adjust the maximum current rating accordingly. The current rating may decrease due to the derating effect at higher temperatures. To ensure safe and reliable operation, customers should evaluate the actual operating environment and select the appropriate current rating based on the expected ambient temperature.

Product Specific:

Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.
- All other soldering methods are at the customers' own risk.

Cleaning and Washing:

- Washing agents used during the production to clean the customer application might damage or change the characteristics of the component, body, pins and termination. Washing agents may have a negative effect on the long-term functionality of the product.
- Using a brush during the cleaning process may deform function relevant areas. Therefore, we do not recommend using a brush during the PCB cleaning process.

Potting and Coating:

- If the product is potted in the customer application, the potting material might shrink or expand during and after hardening. Shrinking could lead to an incomplete seal, allowing contaminants into the components. Expansion could damage the components. We recommend a manual inspection after potting or coating to avoid these effects.

Storage Conditions:

- A storage of Würth Elektronik products for longer than 12 months is not recommended. Within other effects, the terminals may suffer degradation, resulting in bad solderability. Therefore, all products shall be used within the period of 12 months based on the day of shipment.
- Do not expose the components to direct sunlight.
- The storage conditions in the original packaging are defined according to DIN EN 61760-2.
- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.




Packaging:

- The packaging specifications apply only to purchase orders comprising whole packaging units. If the ordered quantity exceeds or is lower than the specified packaging unit, packaging in accordance with the packaging specifications cannot be ensured.

Handling:

- Do not repeatedly operate the component with excessive force. It may damage or deform the component resulting in malfunction.
- In the case a product requires particular handling precautions, in addition to the general recommendations mentioned here before, these will appear on the product datasheet.
- The temperature rise of the component must be taken into consideration. The operating temperature is comprised of ambient temperature and temperature rise of the component. The operating temperature of the component shall not exceed the maximum temperature specified.


