Typical Inductance vs. Current Characteristics:



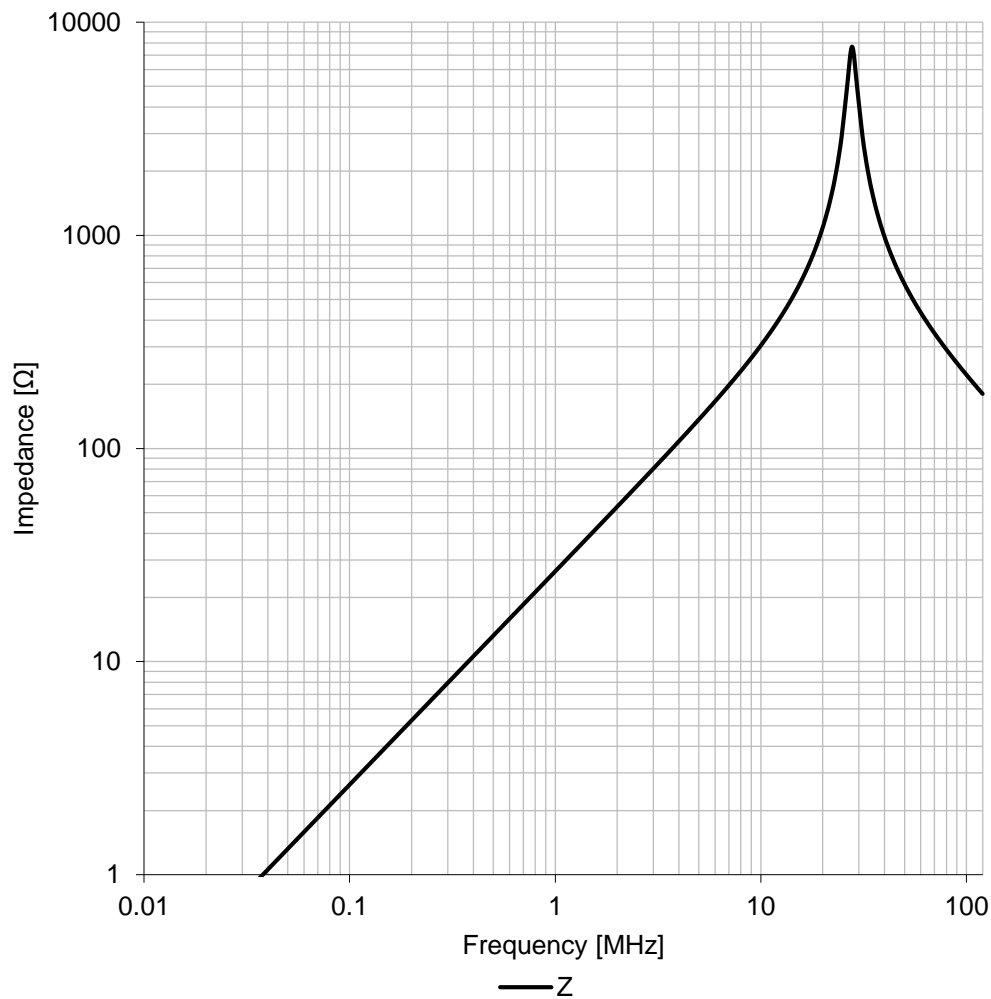
Typical Temperature Rise vs. Current Characteristics:







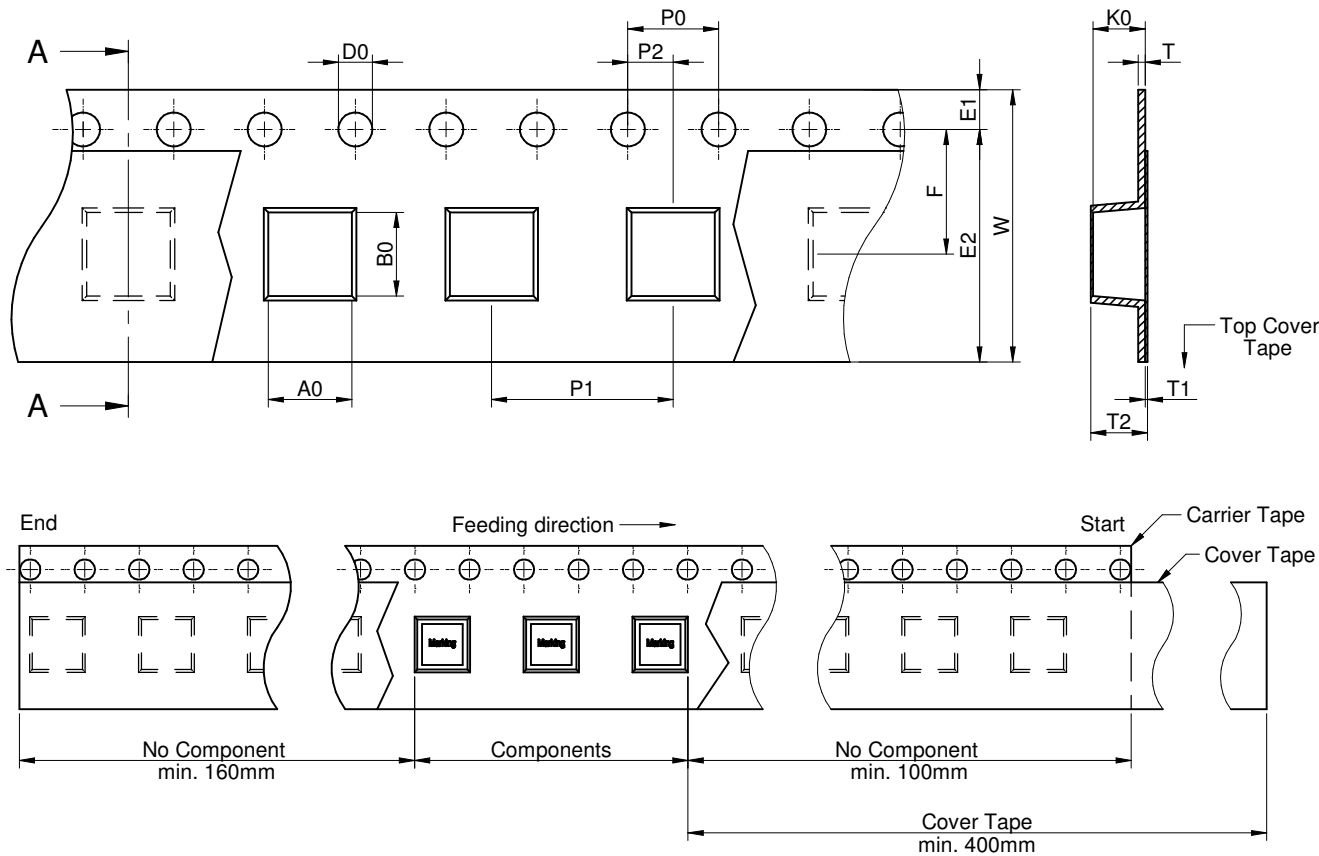
Typical Inductance vs. Frequency Characteristics:

### Cleaning and Washing:




