Soldering

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.

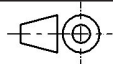
Handling:

- The CMC consists of at least two coils that are wound on a common magnetic core. The electrical separation of the coupled coils, type of isolation, is only functional isolation.
- These windings are arranged in such a way that differential mode current flows through them in opposite directions, which cancels out the magnetic flux in the core.

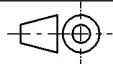
