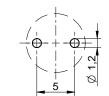

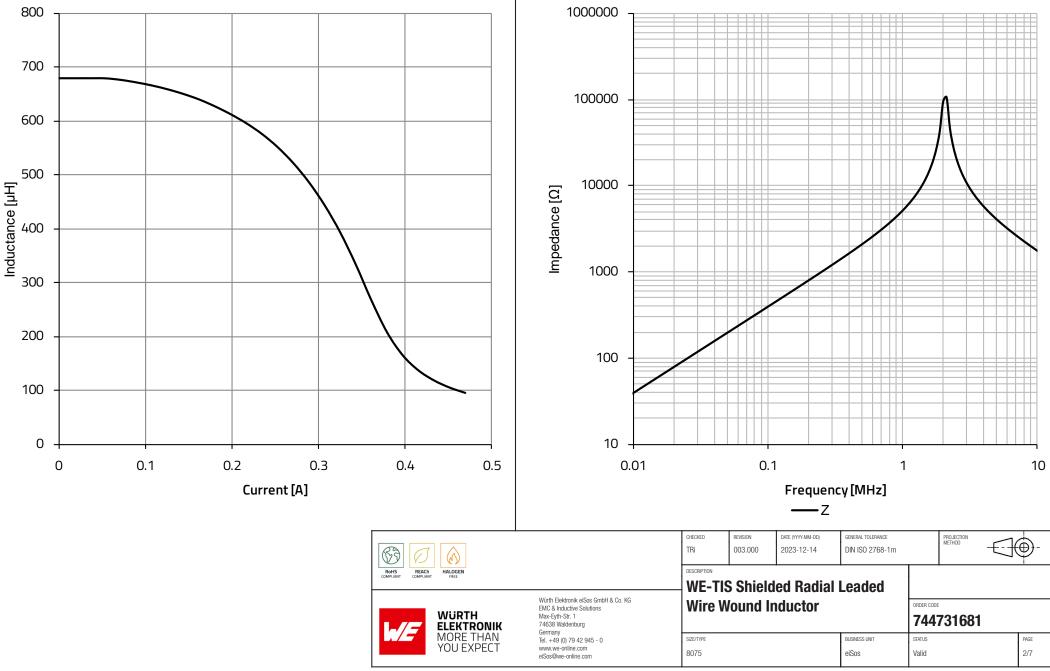

Soldering:
