

Typical Inductance vs. Frequency Characteristics:



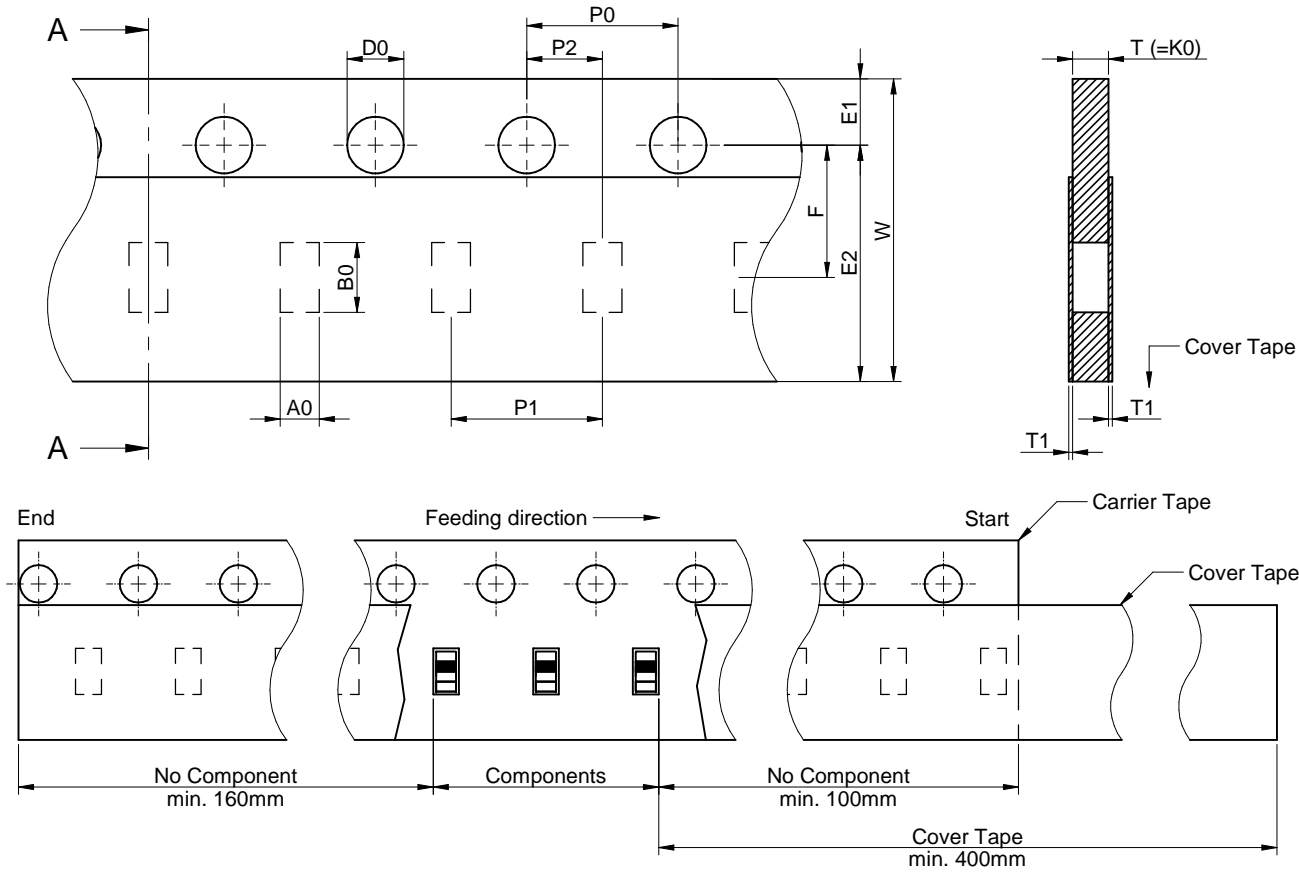
Q-Factor vs. Frequency:

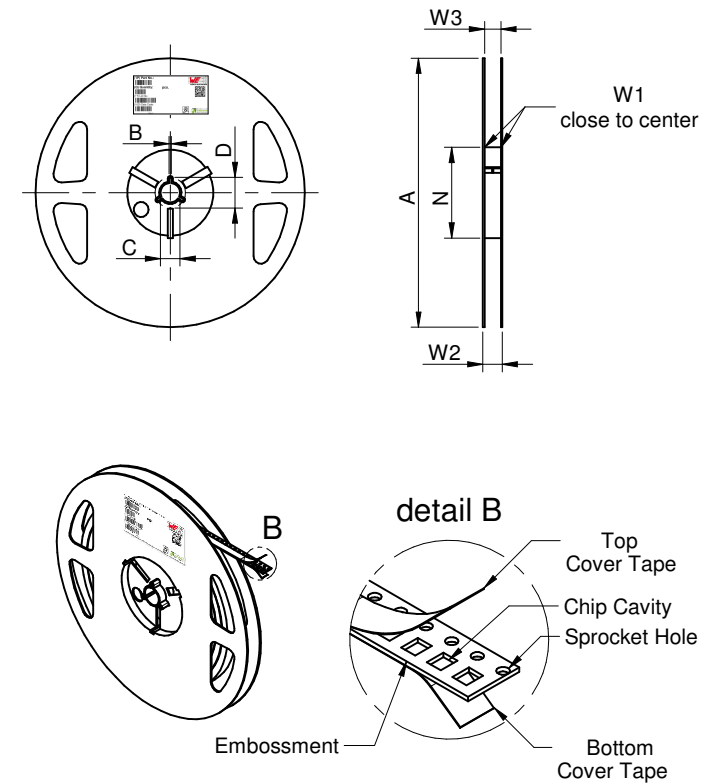



Product specific:

Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty. Wave soldering is allowed for components bigger than 0805 after evaluation and approval.
- All other soldering methods are at the customers' own risk.

Cleaning and Washing:

- Washing agents used during the production to clean the customer application might damage or change the characteristics of the wire insulation, marking or plating. Washing agents may have a negative effect on the long-term functionality of the product.

Potting:

- If the product is potted in the customer application, the potting material might shrink or expand during and after hardening. - The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.




Packaging:
