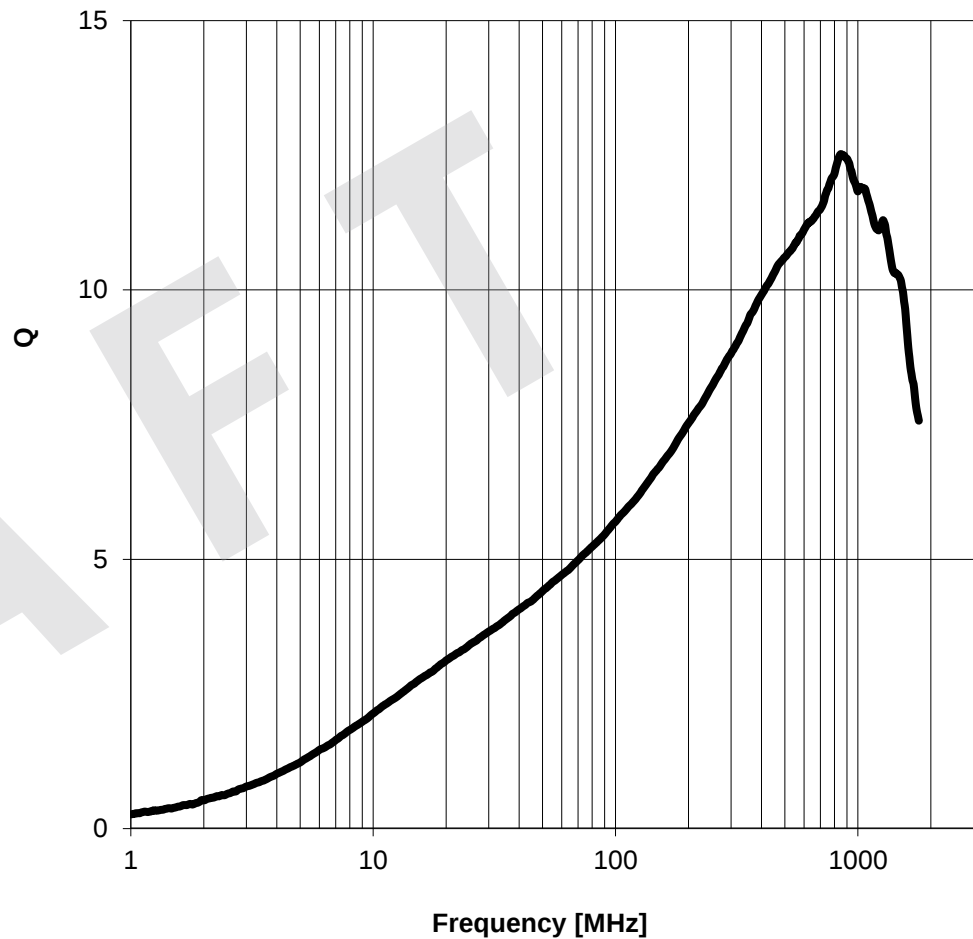

Soldering:
