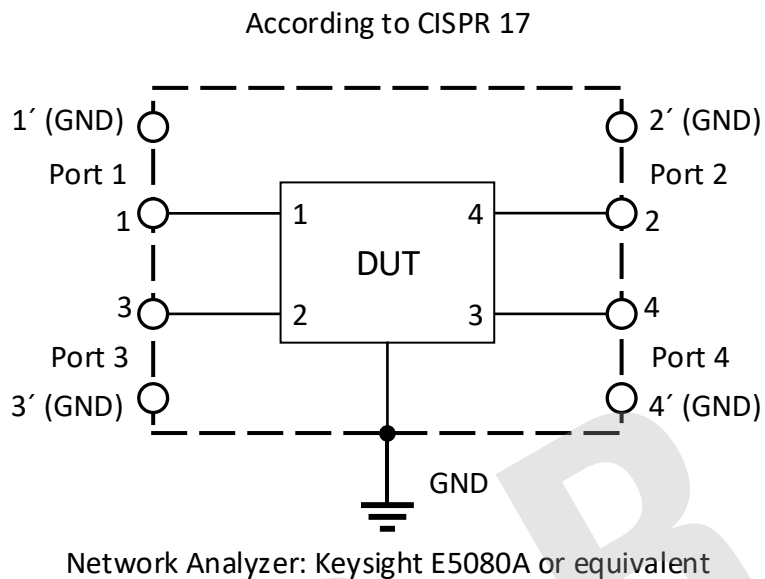


Typical Impedance Characteristics:

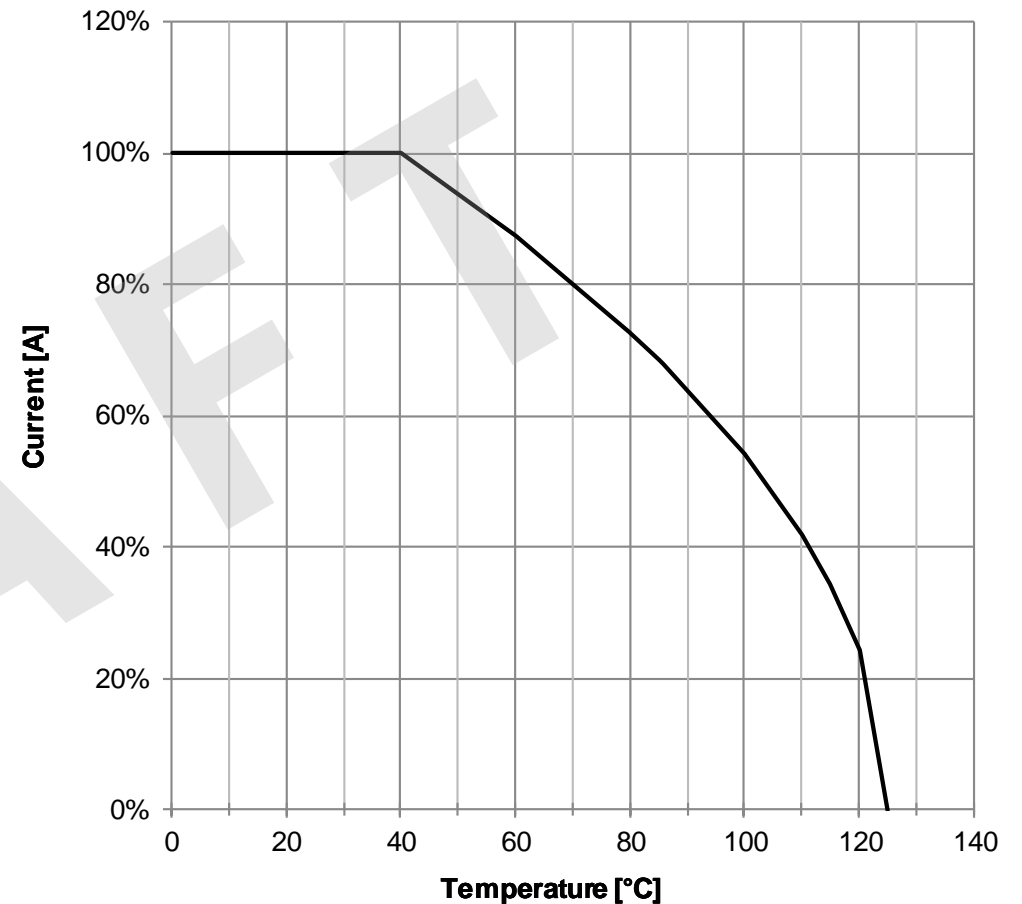



### Packaging:


