

Soldering:

- The solder profile must comply with the Würth Elektronik technical soldering specification. All other profiles will void the warranty.

- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.






Packaging:

- The top loading holders are preferably used for access from above to exchange the cell, simple installation and a secure connection. The side loading holders are preferably used for side access, for mounting on the edge of the PCB and for clearance on the PC.


