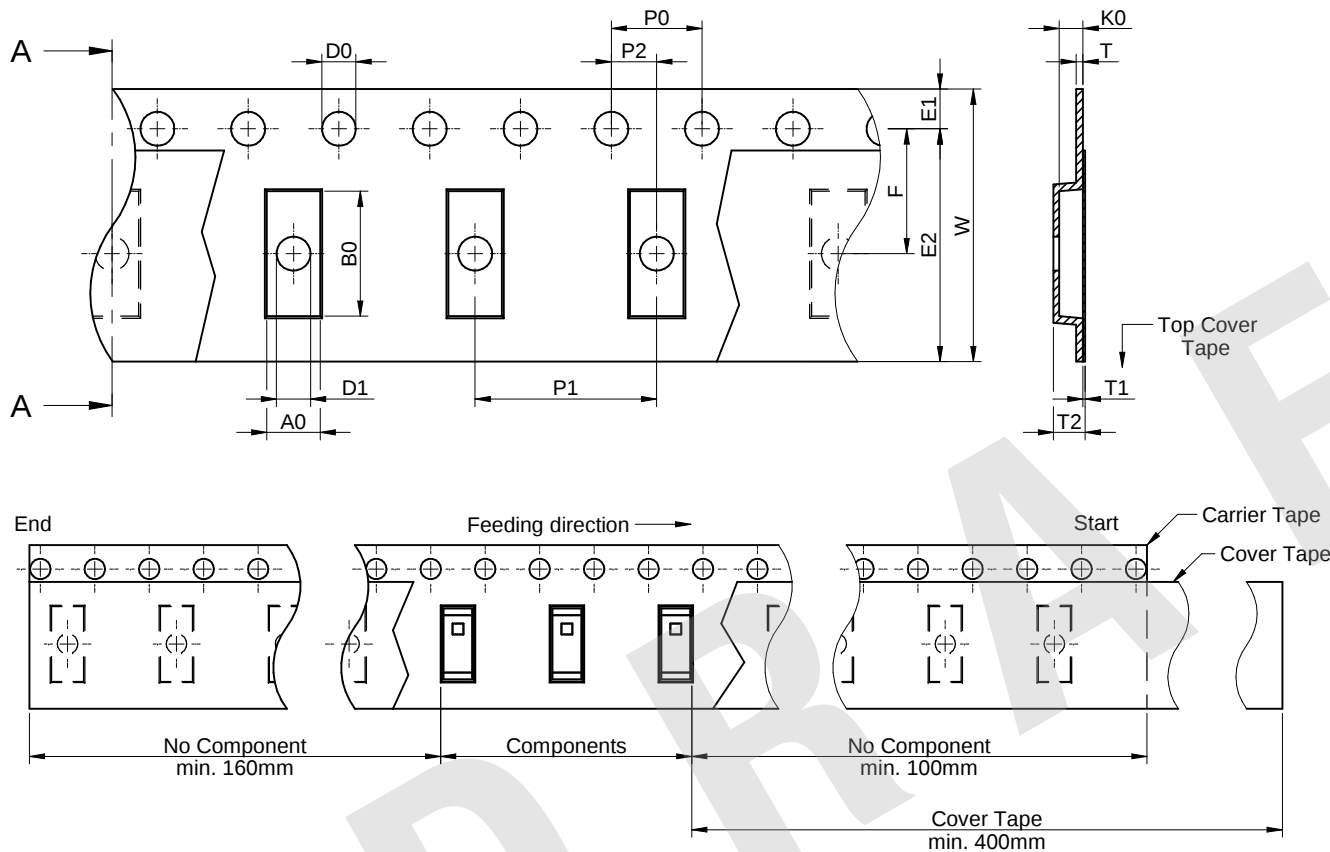


Typical Return Loss:

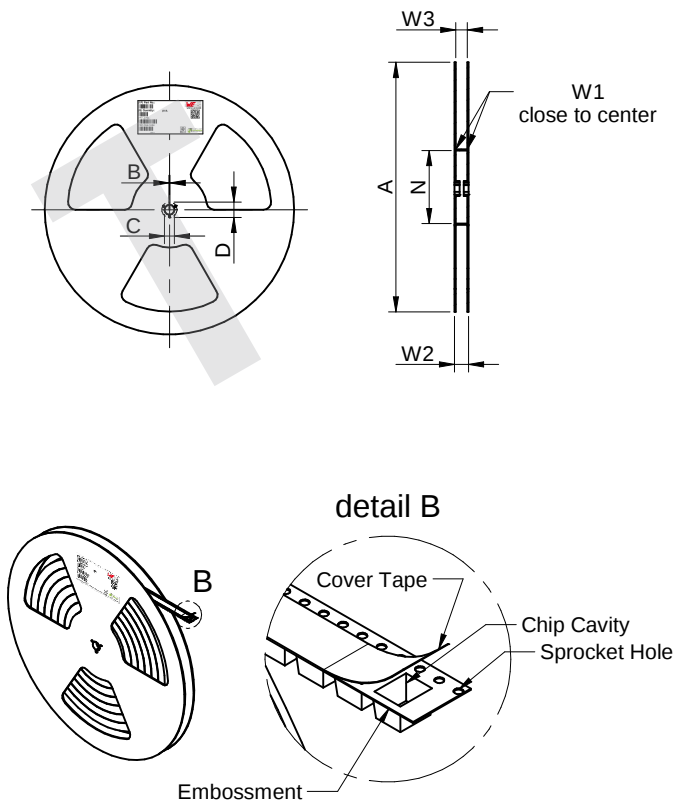

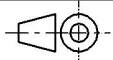
