After part is assembled to PCB, fasten a 4mm lock nut to the bolt going through the PCB. Tighten the nut securely to PCB to ensure protection from vibration.











Typical Inductance vs. Current Characteristics:




Typical Temperature Rise vs. Current Characteristics:




Airflow testing was done with 115mm Ø fan and air velocity was measured directly in front of the part between the fan and part.








Product specific:

Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.
- · All other soldering methods are at the customers' own risk.

Cleaning and Washing:

Washing agents used during the production to clean the customer application might damage or change the characteristics of the wire
insulation, marking or plating. Washing agents may have a negative effect on the long-term functionality of the product.

Potting:

If the product is potted in the customer application, the potting material might shrink or expand during and after hardening. Shrinking

Packaging:
