Typical Inductance vs. Current Characteristics:



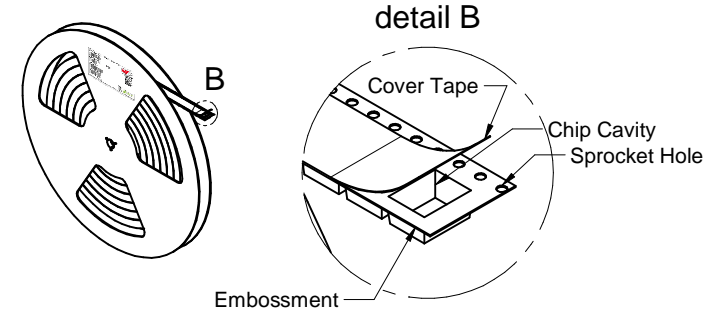
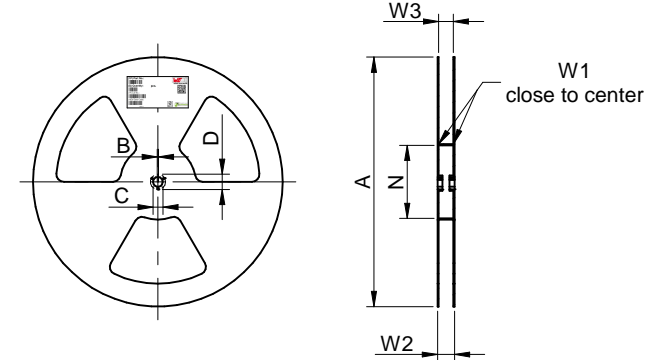
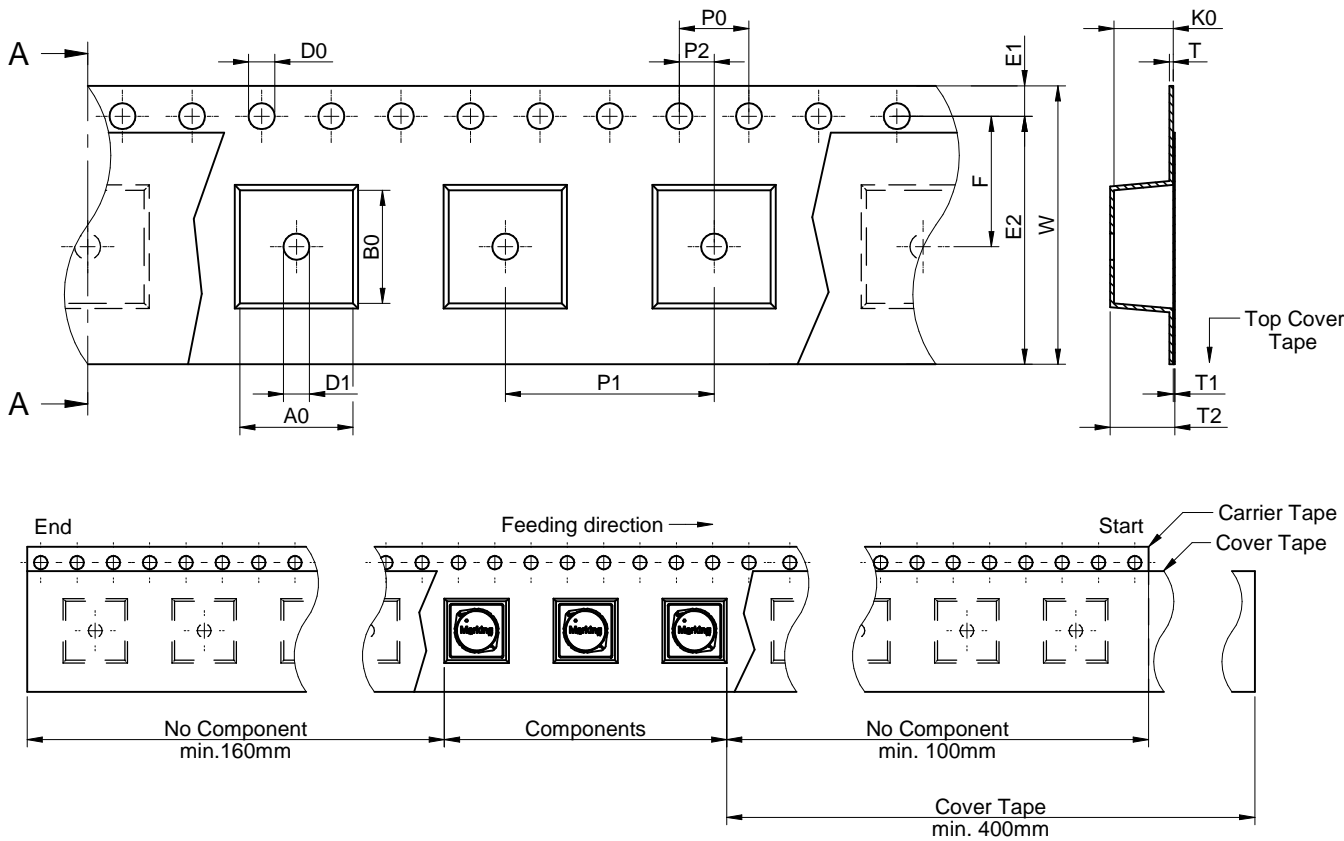
Typical Impedance vs. Frequency:

Product specific:

Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.



Storage Conditions:
