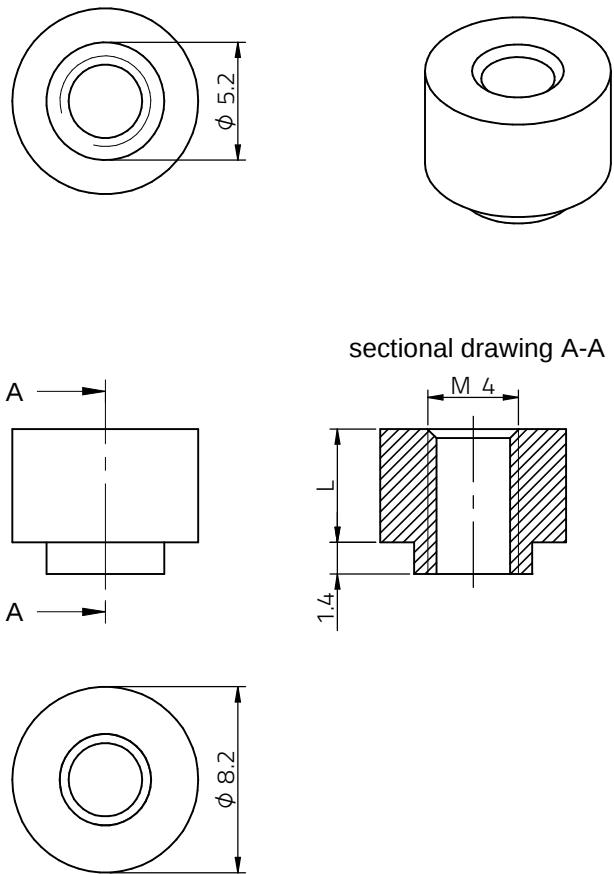
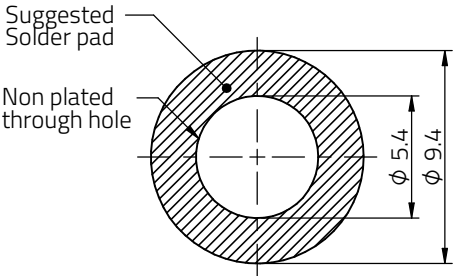

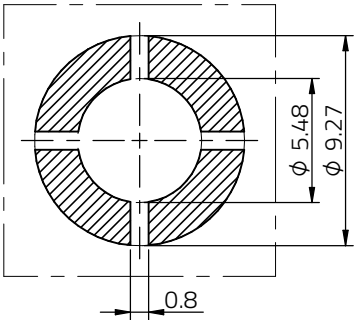
sectional drawing A-A

Soldering:
