Rated Current vs. Voltage:



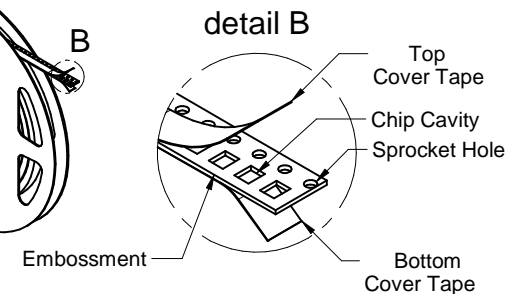
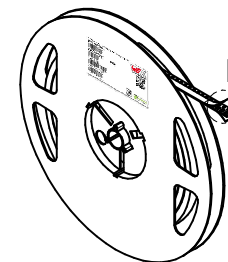
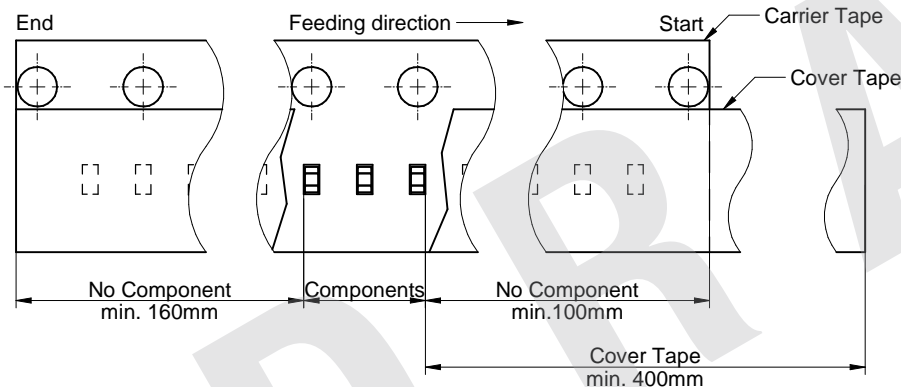
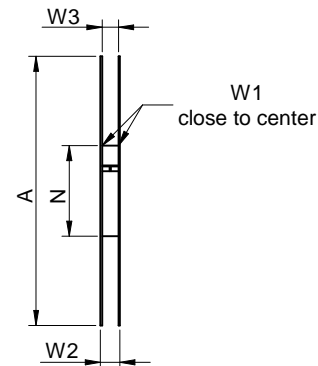
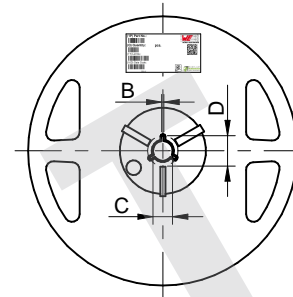
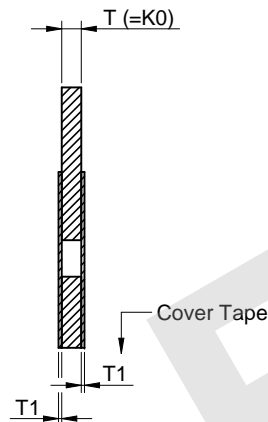
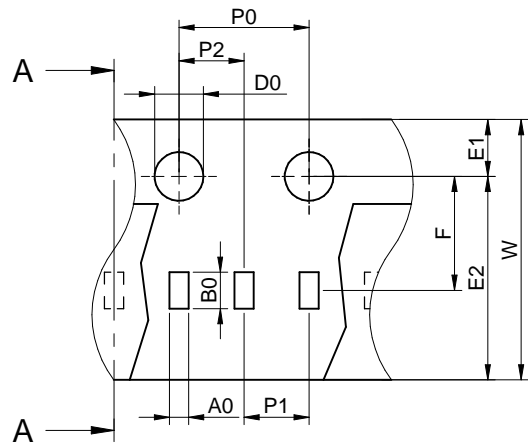

Soldering:




