








# **Recommended Land Pattern: [mm]**

### Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty
- · All other soldering methods are at the customers' own risk.

#### **Cleaning and Washing:**

- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.


### Packaging:
