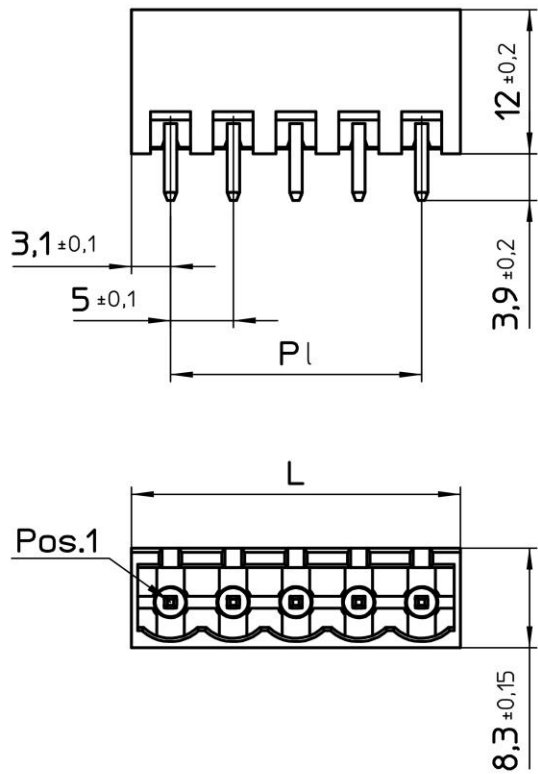
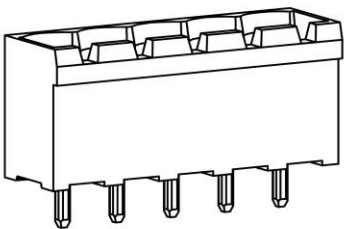


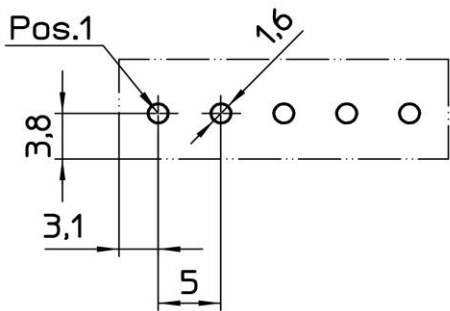

Recommended Hole Pattern (Soldering Side): [mm]



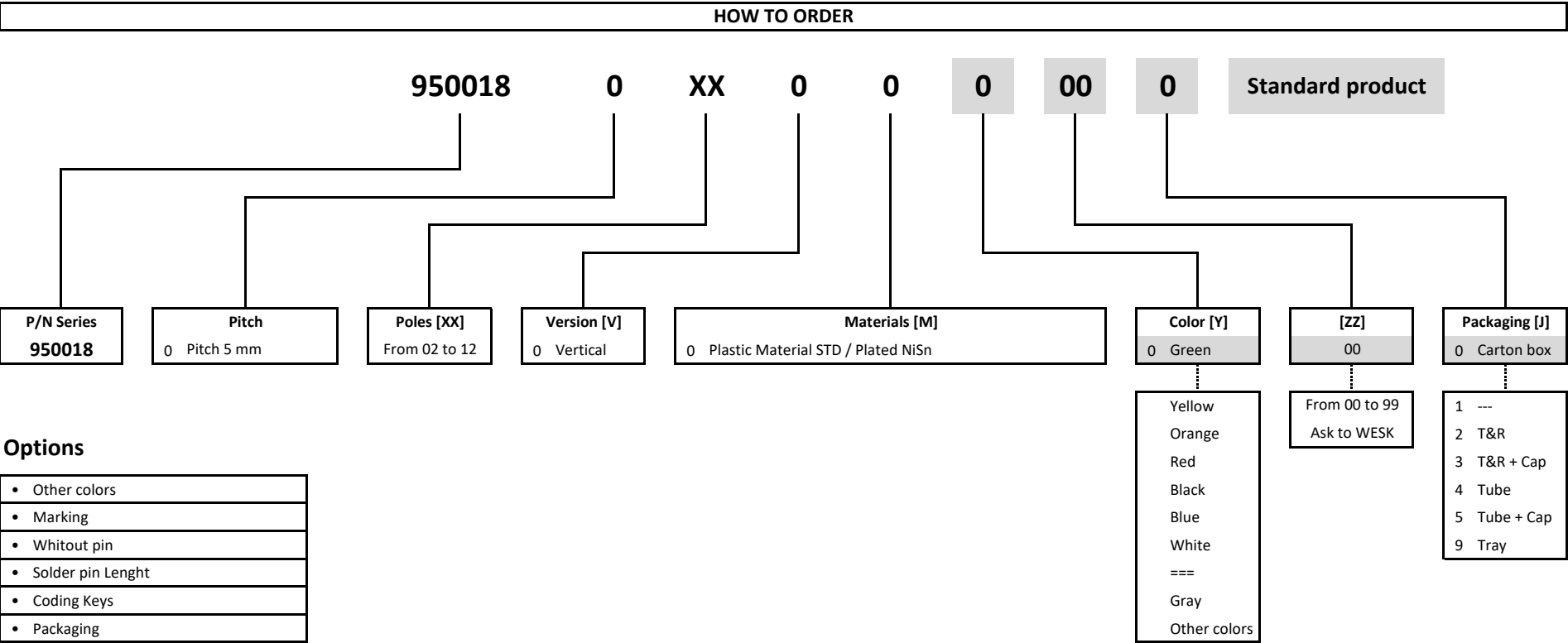

Soldering:

Cleaning and Washing:

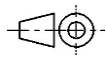

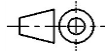
