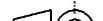
Recommended Hole Pattern (Soldering Side): [mm]



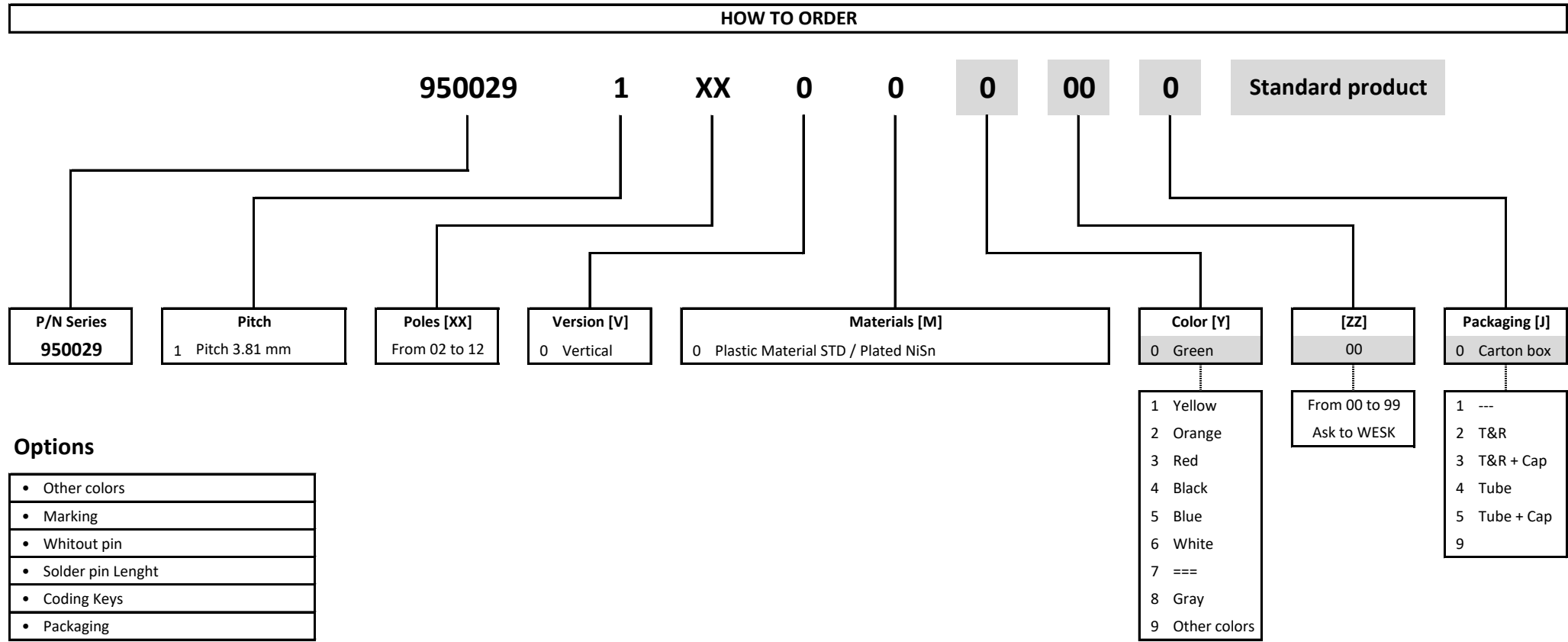
