Recommended Hole Pattern (Component Side): [mm]



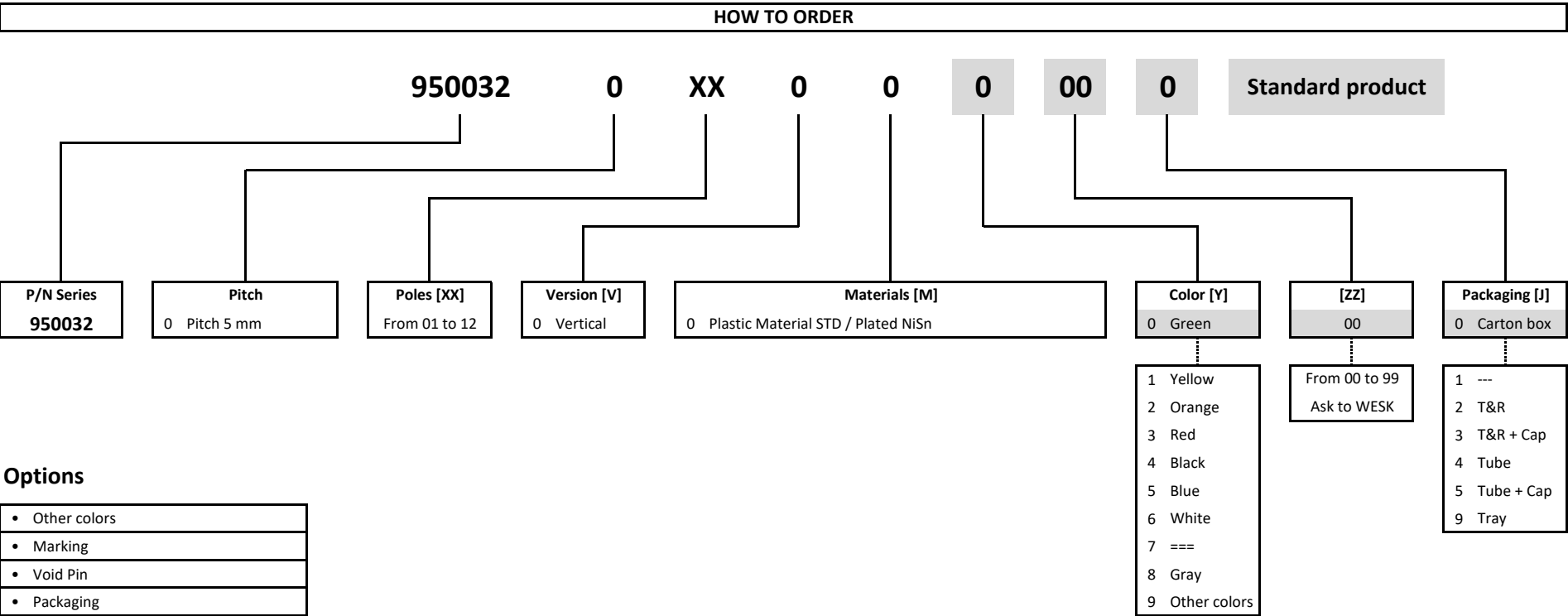

Soldering:

Cleaning and Washing:

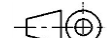
Packaging:

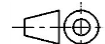
