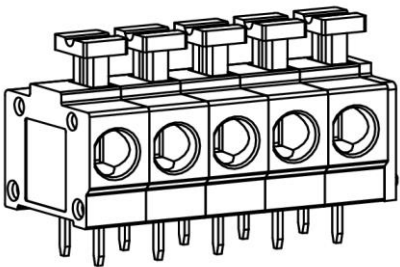
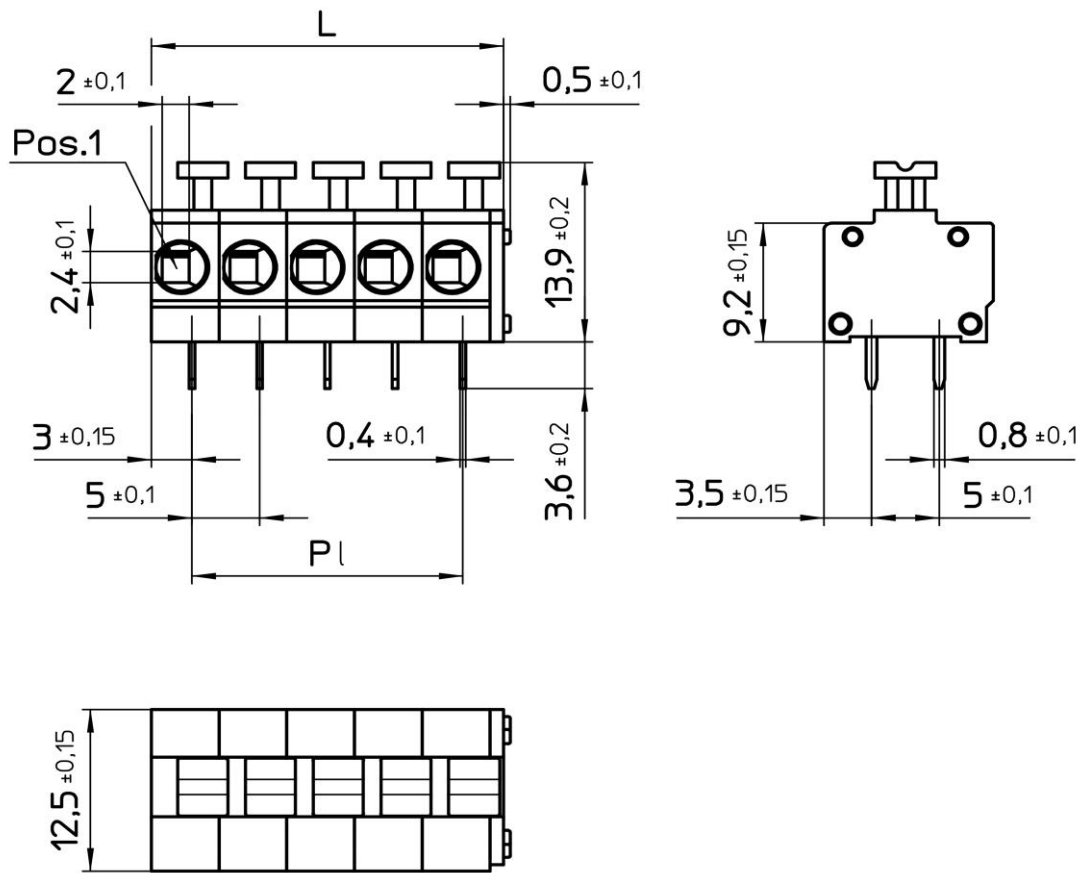
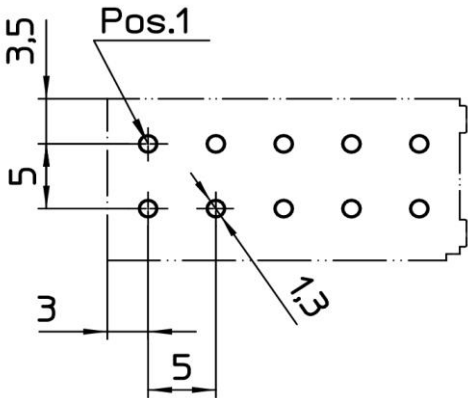

3D View:



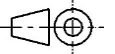
Recommended Hole Pattern (Component Side): [mm]



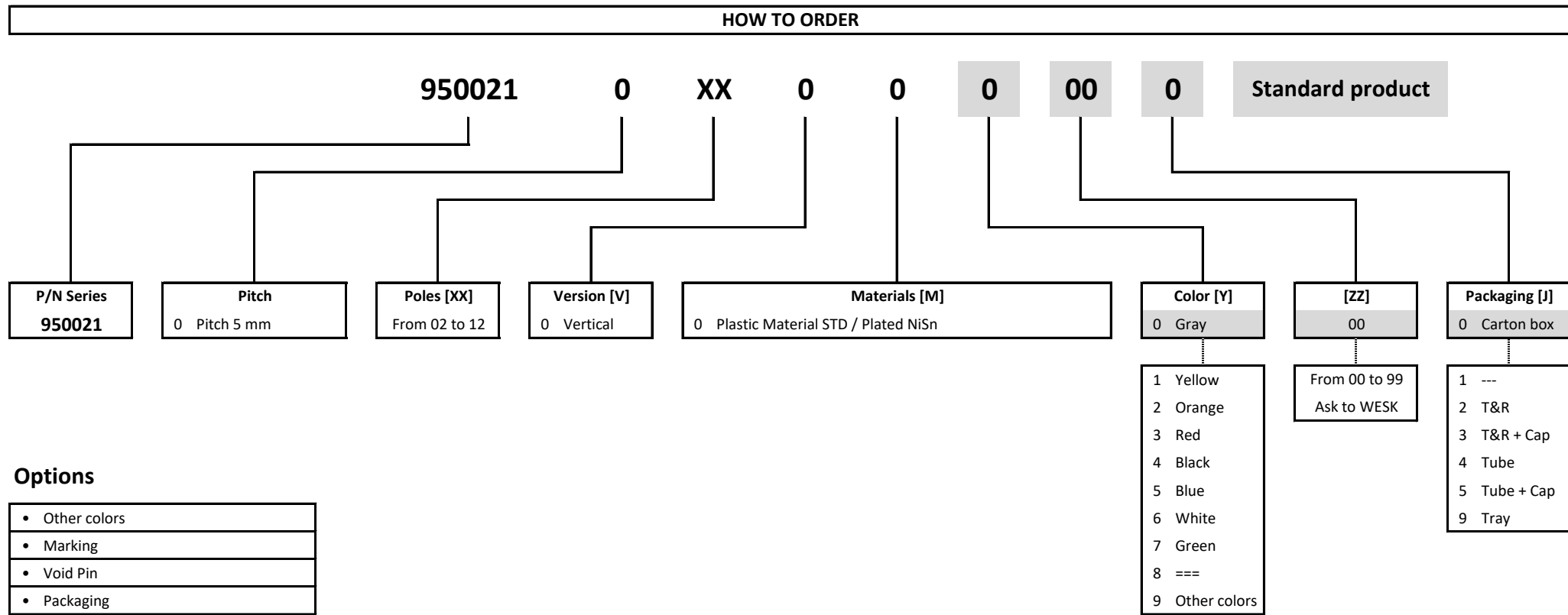

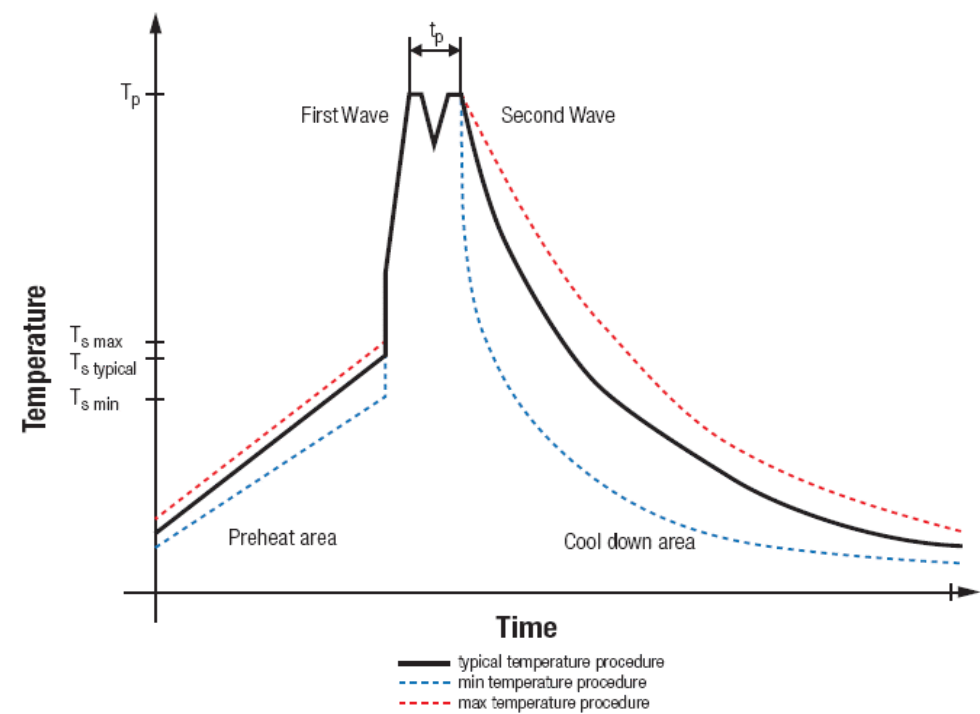

Soldering:

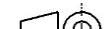

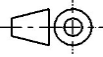
