Recommended Hole Pattern (Component Side): [mm]



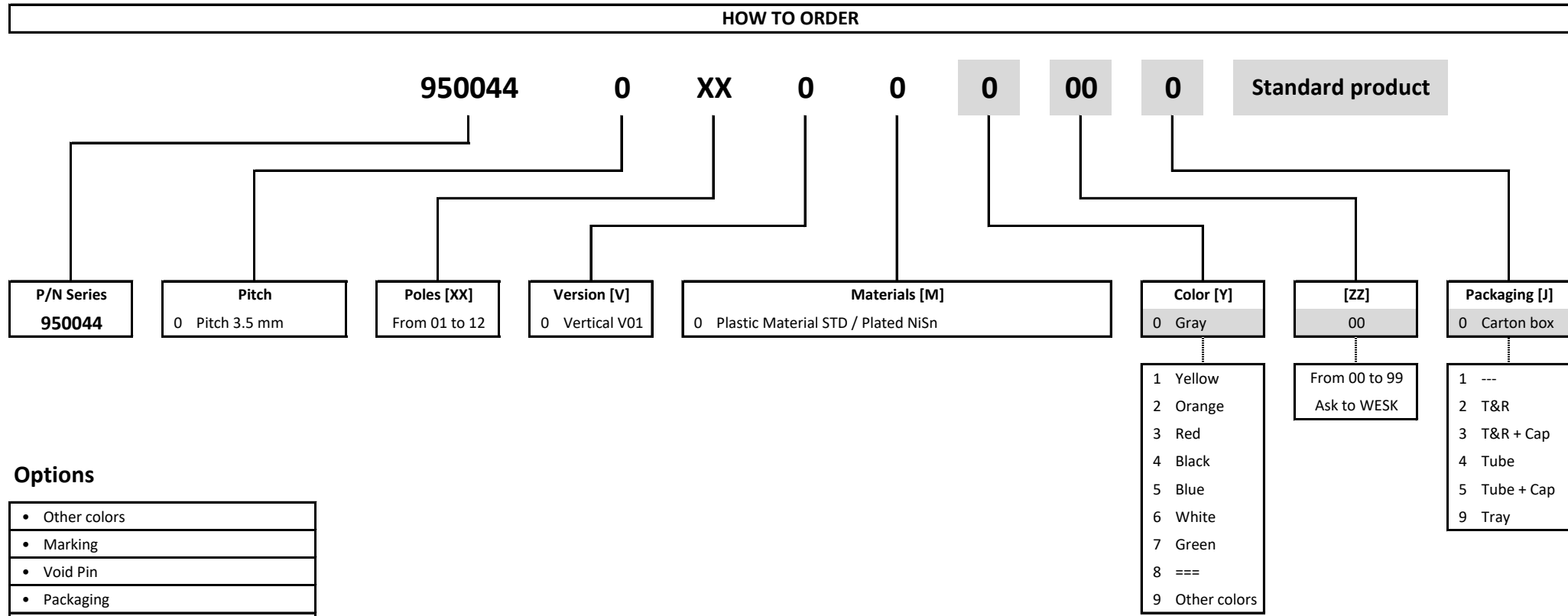

Product Specific:

Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.
- All other soldering methods are at the customers' own risk.

Cleaning and Washing:

- Washing agents used during the production to clean the customer application might damage or change the characteristics of the component, body, pins and termination. Washing agents may have a negative effect on the long-term functionality of the product.
- Using a brush during the cleaning process may deform function relevant areas. Therefore, we do not recommend using a brush during the PCB cleaning process.

Potting and Coating:

- If the product is potted in the customer application, the potting material might shrink or expand during and after hardening. Shrinking could lead to an incomplete seal, allowing contaminants into the components. Expansion could damage the components. Storage Conditions:

- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.

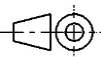
Packaging:
