sectional drawing A-A

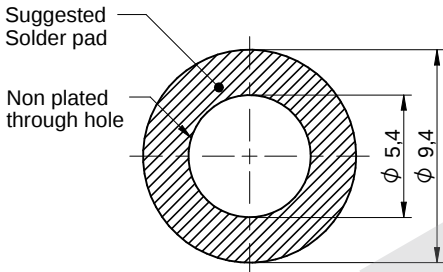

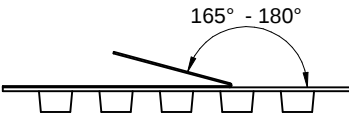


Packaging Specification - Reel: [mm]

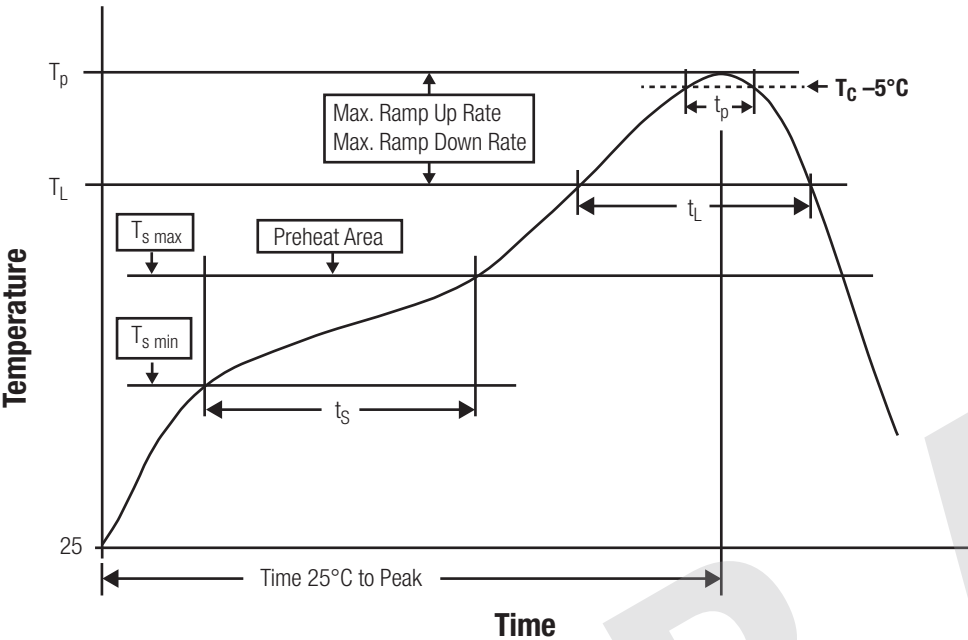

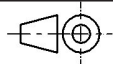

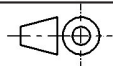
