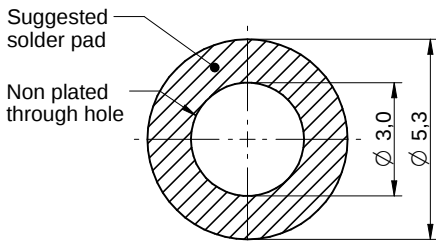


sectional drawing A-A



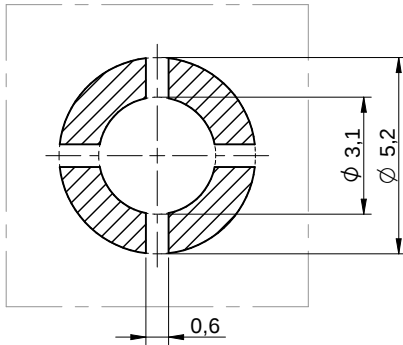

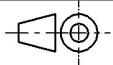
Packaging:
