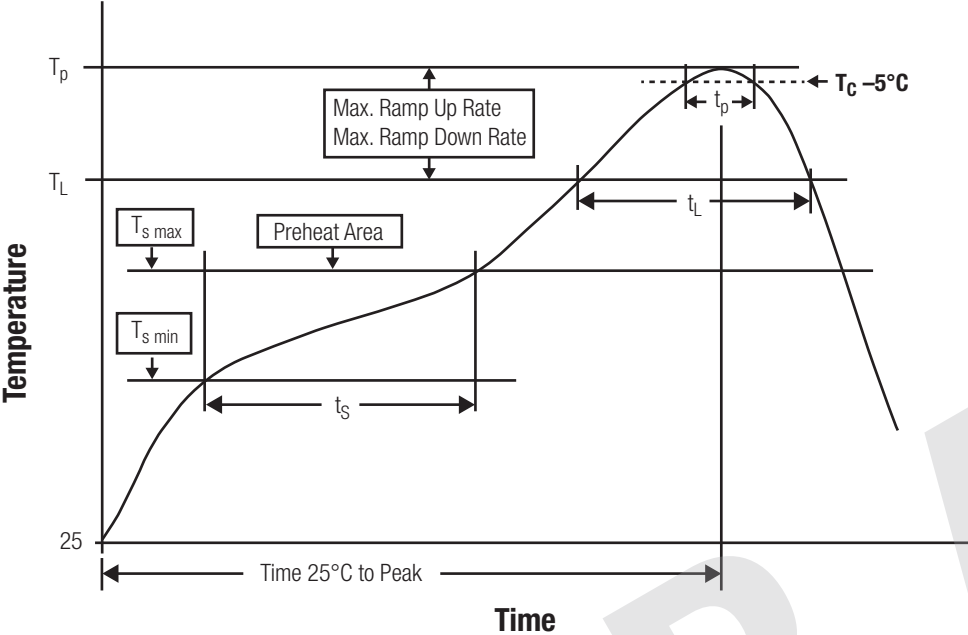

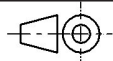
Packaging:

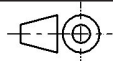
