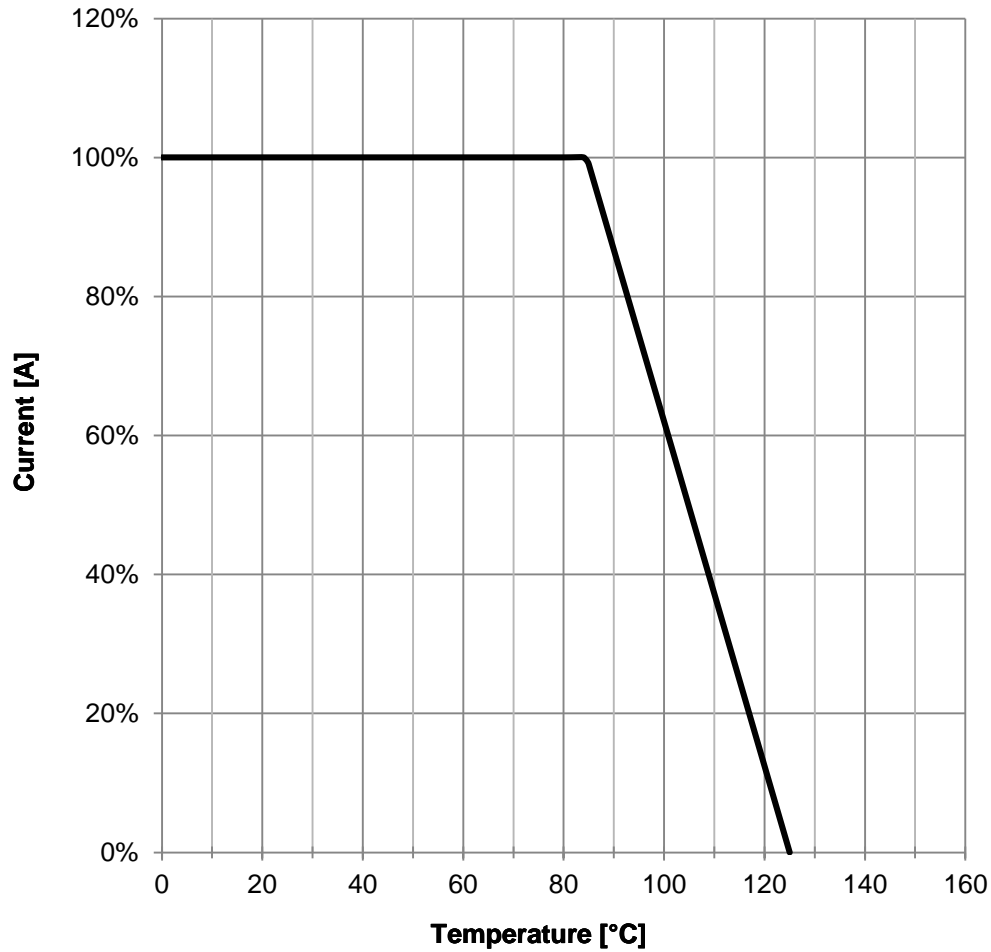



## Packaging:


