## **Product specific:**

Cleaning and Washing:

 Washing agents used during the production to clean the customer application might damage or change the characteristics of the component. Washing agents may have a negative effect on the long-term functionality of the product.

#### Potting:

If the product is potted in the customer application, the potting material might shrink or expand during and after hardening. Shrinking
could lead to an incomplete seal, allowing contaminants into the core. Expansion could damage the components.. We recommend a
manual inspection after potting to avoid these effects.

#### Storage Conditions:

A storage of Würth Elektronik products for longer than 12 months is not recommended. The material characteristics of the electronic
components form a limiting factor for the storage stability. Therefore, all products shall be used within the period of 12 months based on
the day of shipment.

- · Do not expose the components to direct sunlight.
- The storage conditions in the original packaging are defined according to DIN EN 61760-2.
- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.


#### Packaging:

#### Handling:

- Violation of the technical product specifications such as exceeding the maximum outer diameter of the cable will void the warranty.

- If a component is pre-assembled with an adhesive tape, the adhesive duration and operating temperature cannot be guaranteed. This depends on the surface where the component will be mounted on. It also depends on the environmental conditions the component is exposed to. The customer has to evaluate this for his specific application.
- The temperature rise of the component must be taken into consideration. The operating temperature is comprised of ambient temperature and temperature rise of the component. The operating temperature of the component shall not exceed the maximum temperature specified.
