### Q-Factor vs. Frequency:

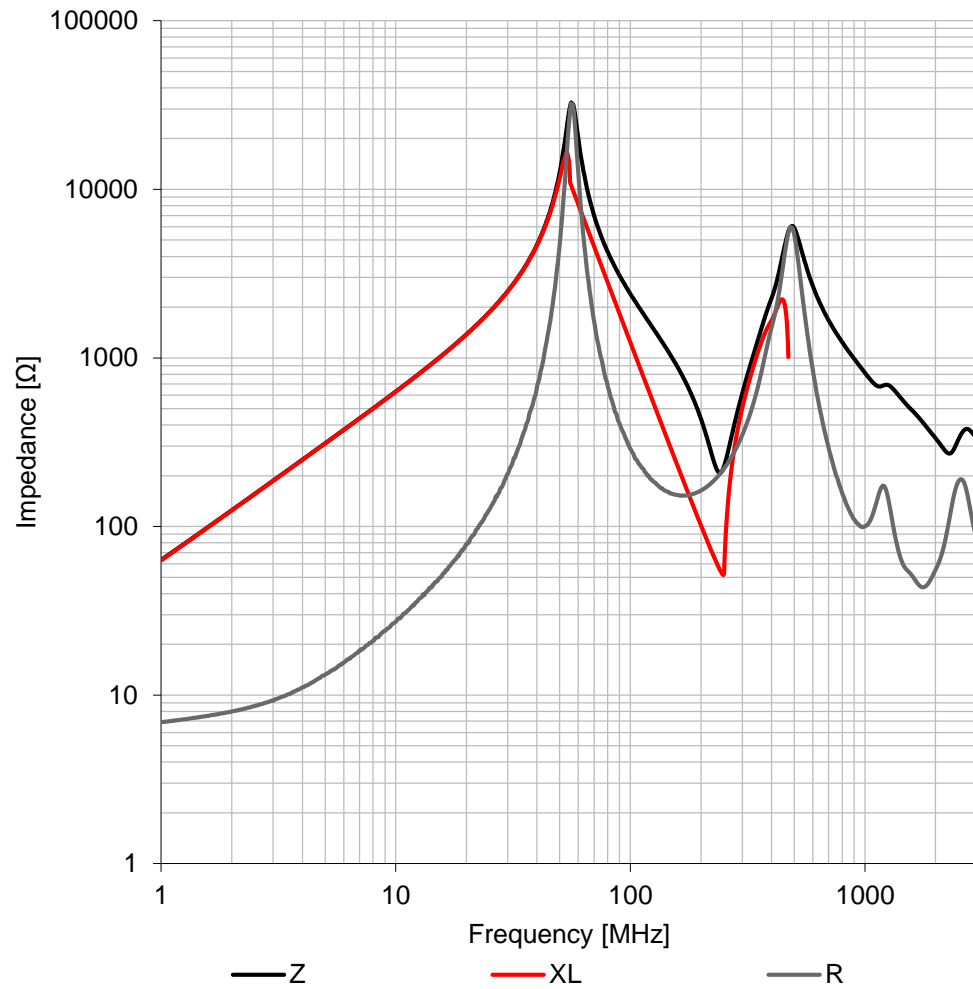

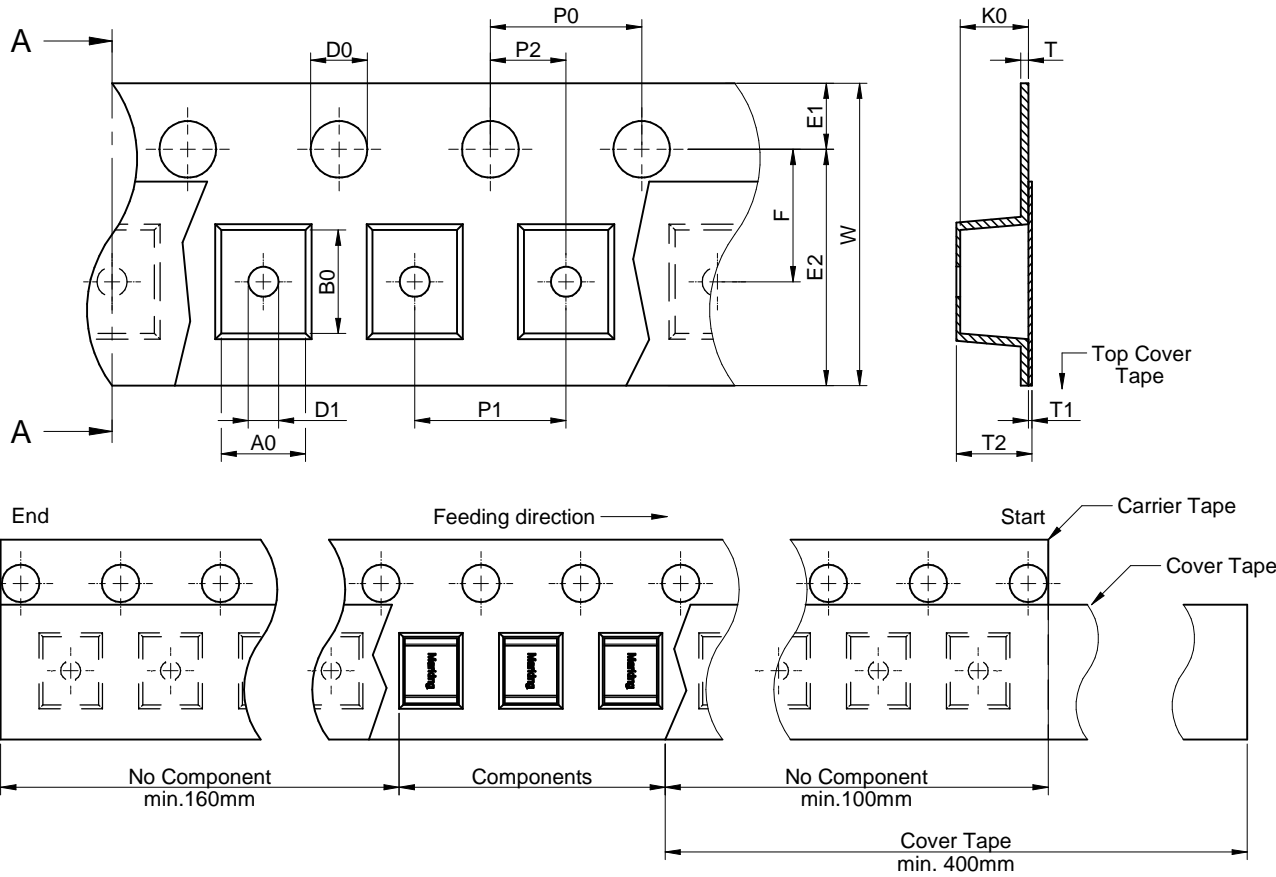
# Typical Impedance vs. Frequency Characteristics

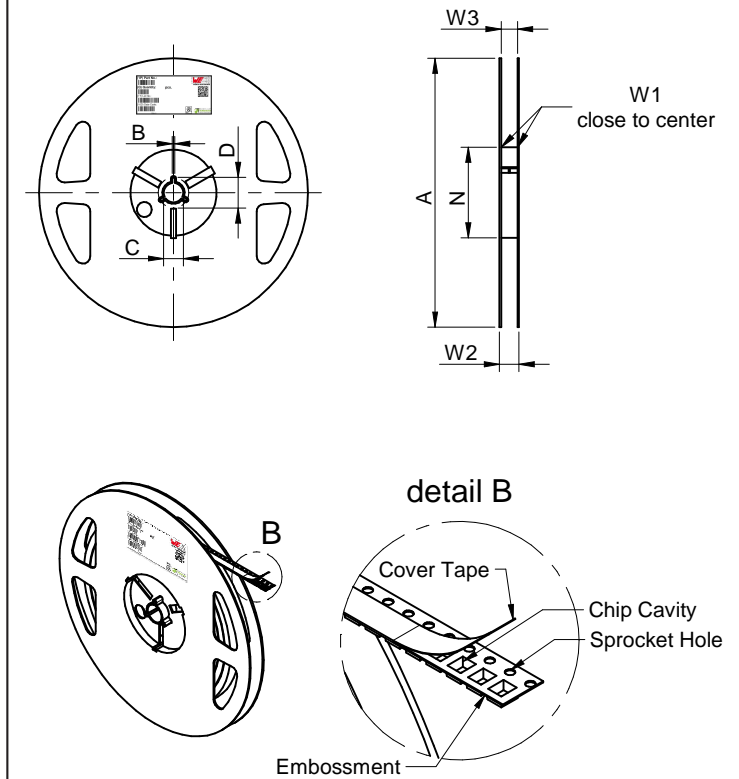

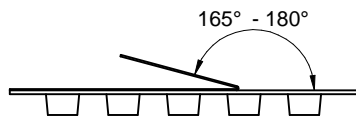



#### Storage Conditions:


