





#### Soldering:

- · The solder profile must comply with the Würth Elektronik technical soldering specification. All other profiles will void the warranty.

- Please notice that the recommended thickness of the soldering paste is 200 μm (max. coplanarity of the product is 150 μm).

### **Cleaning and Washing:**
