Product specific:

- · The solder profile must comply with the Würth Elektronik technical soldering specification. All other profiles will void the warranty

- Strong forces which may affect the coplanarity of the components' electrical connection with the PCB (i.e. pins), can damage the part, resulting in avoid of the warranty.

Cleaning and Washing:

- Washing agents used during the production to clean the customer application might damage or change the characteristics of the wire

Potting:
