### **Product specific:**

### Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.
- All other soldering methods are at the customers' own risk.

### **Cleaning and Washing:**

coating insulation, marking or plating. Washing agents may have a negative effect on the long-term functionality of the product.

### Potting:

- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.


### Packaging:
